SOLE SOURCE/SOLE BRAND REQUEST

I. REQUEST: Provide a description of the features of the product/service or Scope of Work.

The Records, Taxes and Treasury Division (RTT) is requesting approval to negotiate a First Amendment to the Agreement with Destiny Software, Inc., for continued software support and maintenance services of the AgendaQuick (AQ) Agenda Management software, as a Most Reasonable Source. The County has been utilizing software and managed services from Destiny Software since 2008 and discontinued it in 2019 when the County procured Granicus, Inc. Legislative Management solution (Legistar) to replace AQ. RTT desires to migrate the legacy data to the Granicus solution and extending the Agreement with Destiny Software will allow the necessary time and resources to complete this migration.

AQ is proprietary to and is available only directly from Destiny Software. There are no resellers or channel partners available in the marketplace. Given the history of County use of the software, this is the Most Reasonable Source from which to procure software support and maintenance services.

Only Sole Source/Uniqueness

The AQ Agenda Management software and maintenance services are proprietary to and thus available only from Destiny Software. This procurement would serve to continue software support and maintenance of AQ until the existing data can be migrated successfully to the Legistar application.

Business Case (One/Most Reasonable Source or One/Most Reasonable Brand)

Operational Compatibility - replacement parts from alternate suppliers are not interchangeable with original part and causes equipment incompatibility. Previous findings and/or documentation is included with this request.

Ease of Maintenance - maintenance or retooling prohibits competition. Section III, Comparative Market Research includes estimated costs associated with changing current source and/or brand.

Follow-On - potential for continued development or enhancement with same supplier and eliminates costs incurred by using different supplier. Section III, Comparative Market Research includes estimated costs for replacing current or existing system.

Complies with existing community and safety standards, and/or laws, rules, and regulations.

Exempted from the Procurement Code – per Section 21.5 of Broward County Administrative Code.

The County has already invested in the Granicus Legislative Meeting and Agenda Management Suite of software applications, which includes web hosting, web streaming, web design, agenda workflow, meeting management, and boards and commissions services.

Once the migration of AQ legacy data to Legistar application is complete, the County will save approximately \$5,900 annually in software support and maintenance fees.
