- I. Planning Council Staff Transmittal Recommendation February 15, 2022

Planning Council staff recommends approval of the proposed amendment to the Natural Resource Map Series - Eastern Broward County Wetlands Map.

As the Planning Council is aware, the Broward County Charter requires at least one Planning Council public hearing and Article 1.2(A) of the *Administrative Rules Document: BrowardNext* outlines the following circumstances in which a second Planning Council public hearing may be recommended or required:

- (1) At its initial public hearing, the Planning Council takes an action to recommend denial of a proposed amendment; or
- (2) At its initial public hearing, the Planning Council takes an action to recommend approval subject to meeting specific criteria or policy prior to a second Planning Council public hearing; or
- (3) At its initial public hearing, the Planning Council votes by a majority of the members present with a minimum of six (6) affirmative votes for a second Planning Council public hearing; or
- (4) If the County Commission requests by a vote of the majority of members present to request a second Planning Council public hearing; or
- (5) If an objection or comment on adverse impacts to important state resources or facilities is issued during the State of Florida Chapter 163 review process; or
- (6) If State of Florida Chapter 163 requires or is modified to require a second local planning agency public hearing.

If the Planning Council chooses to require a second Planning Council public hearing per Article 1.2(A)(1)(2) or (3), such recommendation must be made as part of its motion.

INTRODUCTORY INFORMATION/PLANNING ANALYSIS

Pursuant to Policy 2.22.3 of the BrowardNext - Broward County Land Use Plan, the Broward County Resilient Environment Department (RED) is required to update the Natural Resource Map Series - Eastern Broward County Wetlands Map (Map) every other year. The Map was previously updated in 2020 based on actions from January 1, 2018 through December 31, 2019. The proposed revisions are based on actions that the RED staff has taken from January 1, 2020 through December 31, 2021. Those actions include observing or delineating wetlands on a parcel, issuing an Environmental Resource License which formally identifies wetlands or removing wetlands that are no longer environmentally significant. These actions resulted in the addition of 162.96 acres and the removal of 222.007 acres. In addition, sites that were determined to be scrivener's errors due to no historical or current evidence of wetlands have been removed from the Map; these sites are not included in the removal total. Attachment 1 provides a detailed listing of the proposed additions and deletions. Attachment 2 depicts the revised Broward County Wetlands Map.

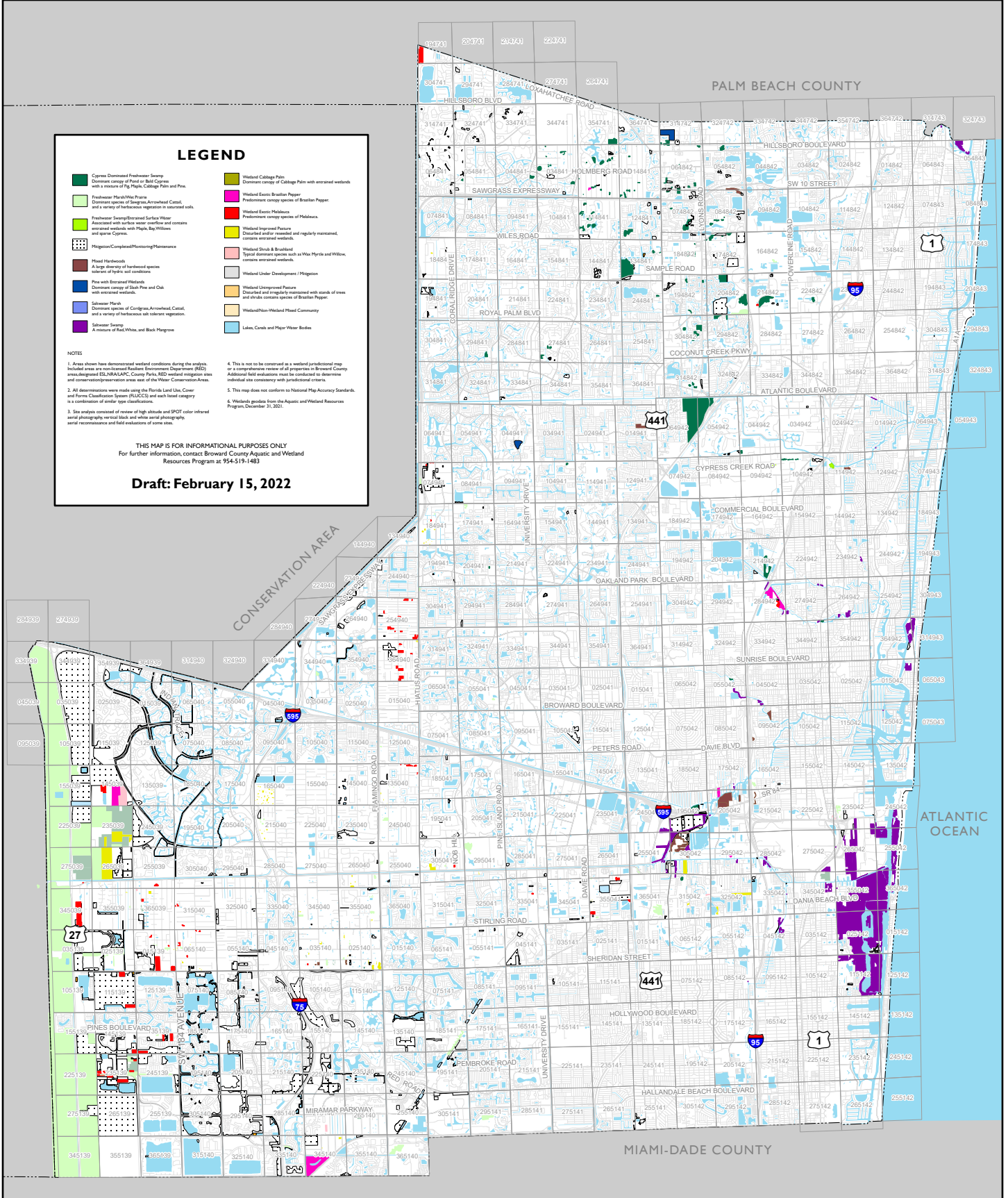

Cypress Dominated Freshwater Swamp Dominant canopy of Pond or Salt Cypress with a mixture of Big Palm, Cabbage Palm and Pine.	Wetland Cabbage Palm Dominant canopy of Cabbage Palm with scattered wetlands.
Freshwater Marsh/Water Prairie Dominant species of Sedges, Arrowweed Cattail, and a variety of herbaceous vegetation in scattered soils.	Wetland Exotic Brazilian Pepper Predominant canopy species of Brazilian Pepper.
Freshwater Swamp/Scattered Surface Water Associated with surface water, scattered and contains scattered wetlands, with Maple Bay Willow and other species.	Wetland Exotic Melaleuca Predominant canopy species of Melaleuca.
Wetland/Completed/Postponing/Remnant	Wetland Improved Pasture Disturbed and/or managed and regularly maintained, contains scattered wetlands.

Saltwater Marsh Dominant species of Cordgrass, Arrowweed, Cattail, and a variety of herbaceous salt tolerant vegetation.	Wetland/Non-Wetland Mixed Community
Saltwater Swamp A mixture of Salt Water and Black Mangrove	Lakes, Canals and Major Water Bodies

NOTES

1. Areas shown have demonstrated wetland conditions during the analysis. Included areas are non-located Resident Environment Department (RED) areas designated (EIA, NALAC, County Parks, RED) wetland mitigation areas and conservation/preservation areas east of the Water Conservation Areas.
2. All interpretations were made using the Florida Land Use, Cover and Form Classification System (FLUCCS) and each land category is a combination of similar type classifications.
3. Six aerials consisted of color of high altitude and SPOT color infrared aerial photography vertical black and white aerial photography, aerial reconnaissance and field evaluations of some sites.
4. This is not to be construed as a wetland jurisdictional map or a comprehensive review of all properties in Broward County. Additional field evaluations must be conducted to determine individual site compliance with jurisdictional criteria.
5. This map does not conform to National Map Accuracy Standards.
