14	meetings, NOW, THEREFORE,

1	6.	Delegation Requests. Any person shall be entitled to have a					
2		delegation request placed on the official agenda of a regular meeting					
3		of the County Commission <del>concerning any</del> provided the request is					
4		consistent with the conditions stated in this subsection 6. The					
5		delegation request must concern a matter within the scope of the					
6		County Commission's jurisdiction, and shall be entitled to speak					
7		toward that delegation request such that the County Commission can					
8		directly and materially affect the matter that the delegation request					
9		<u>concerns</u> .					
10	(a) Any person who desires to speak to the County Commission						
11	regarding his or her a delegation request must properly and						
12		<u>fully</u> complete and return a delegation request <del>, in the</del> form <u>, to</u>					
13		be provided by the County Administrator, no later than fifteen					
14		(15) days before the County Commission meeting at which					
15		the person desires to speak. The delegation request form					
16		shall require identification of must identify by name the person					
17	desiring to speak and affirmation that the topic upon which the						
18	person desires to speak is within the jurisdiction of the County						
19	Commission, must identify the particular topic on which the						
20	person desires to speak, and must include an affirmation that						
21	the particular topic is within the scope of the County						
22	Commission's jurisdiction. The person may submit						
23		supplemental information with the delegation request form,					
24		which the County Administrator shall furnish to the County

1 Commission if the delegation request is placed on the 2 agenda. The person may also identify on the delegation 3 request form up to two (2) other persons who have an interest 4 in desire to speak to the County Commission on the topic as 5 part of the same delegation request. 6 (b) If the County Administrator determines the delegation request 7 is properly and fully completed and the particular topic is 8 within the scope of the County Commission's jurisdiction, such 9 that the County Commission may directly and materially affect 10 the matter, T the County Administrator shall place a properly 11 completed the delegation request on the first available official 12 agenda in which there is sufficient time to hear the delegation 13 request, but in no event shall there be more than three (3) 14 delegations requests at <u>during</u> any County Commission 15 meeting. When the County Administrator places a delegation 16 request on the official agenda, the County Administrator shall 17 also furnish to the County Commission any appropriate 18 backup information, as determined by the Countv 19 Administrator, regarding the topic the person wishes to 20 discuss. 21 (c) For each delegation request, the person who submitted the 22 delegation request form may address the County Commission 23 for three (3) minutes, and the two (2) interested persons, if 24 any, identified on the delegation request form may also

address the County Commission on the same topic for two (2) 1 2 minutes each, subject to Section 18.6.d. 18.6.c. 3 . . . 4 5 Section 2. Severability. 6 If any portion of this Administrative Code Resolution is determined by any court to 7 be invalid, the invalid portion will be stricken, and such striking will not affect the validity 8 of the remainder of this Resolution. If any court determines that this Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or 9 circumstance, such determination will not affect the applicability of this Resolution to any 10 other individual, group, entity, property, or circumstance. 11 12 13 Section 3. Inclusion in the Broward County Administrative Code. 14 It is the intention of the Board of County Commissioners that the provisions of this 15 Administrative Code Resolution become part of the Broward County Administrative Code 16 as of the effective date.
