#### **CBE Compliance Comments:**

Alen Construction submitted the required documentation in accordance with the solicitation's requirements and are compliant with the CBE Program requirements.

Big Dog Construction Services, Inc., Home Express Corp. d/b/a Home Express Builders, Sagoma Construction Services, Inc. and Shiff Construction & Development did not include LOIs with their respective bid submittals. The firms were given three (3) business days within which to provide executed Letters of Intent (LOIs) that meet the established goal or provide documentation of their respective good faith efforts to meet the goal. Both firms responded within the stipulated three-day period and provided LOIs that meet the established goal. Big Dog Construction Services, Inc. and Home Express Corp. d/b/a Home Express Builders are deemed compliant with the CBE requirements of the solicitation.

Sagoma Construction Services, Inc. did not include LOIs with its bid submittal. The firm was given three (3) business days within which to provide executed LOIs that meet the established goal or provide documentation of its good faith efforts to meet the goal. The firm responded within the stipulated timeframe but submitted LOIs that contained technical errors with regard to the CBE participation percentage of its subcontractors. The LOIs overstated the overall CBE participation as 33.00% when, based on the Total Bid Amount and the proposed subcontract amounts, it should be 24.86%. The firm was notified of the technical errors, and provided with an opportunity to correct the percentage calculations. In its response to the OESBD, Sagoma Construction Services, Inc. indicated that the Total Bid Amount in Periscope (f/k/a BidSync) reflected their intended bid submittal plus the bid allowance amount that Periscope automatically added to all Bidders' submittals. In accordance with the Business Opportunity Act of 2012 (the Act), as amended, Section 1-81.1(d)(12), which states the determination of Good Faith efforts shall be made by the Program Director upon evaluation of the Bidder's response, the OESBD Director determined that Sagoma Construction Services, Inc. has demonstrated good faith efforts to meet the established CBE goal. Sagoma Construction Services, Inc. is deemed compliant with the CBE requirements of the solicitation.

Cosugas, LLC d/b/a Herman Giacomelli submitted LOIs that were missing information and that had technical errors. Danto Builders, LLC d/b/a Maximum Energy Payback submitted an LOI with technical errors. The Marc J. Parent Company, Inc. d/b/a PB Builders, LLC submitted LOIs that were missing information. Travis Contracting Services, Inc. submitted LOIs that were missing information and that contained technical errors. The firms were given three (3) business days to correct the errors and provide the missing information on their respective LOIs. Cosugas, LLC d/b/a Herman Giacomelli, Danto Builders, LLC d/b/a Maximum Energy Payback, The Marc J. Parent Company, Inc. d/b/a PB Builders, LLC and Travis Contracting Services, Inc. provided the requested information within the stipulated timeframe and are deemed compliant with the CBE requirements of the solicitation.

Gulf Building, LLC submitted LOIs with its bid submittal, one of which was executed with a firm that is not CBE-certified. Gulf Building, LLC was given three (3) business days to either replace the non-CBE firm with a CBE firm or take no further action as its submitted LOIs, even without a replacement firm, met the established goal. Gulf Building, LLC responded within the stipulated timeframe and opted not to replace the non-CBE firm with a CBE firm. Gulf Building, LLC is deemed compliant with the CBE requirements of the solicitation.

Waypoint Contracting, Inc. submitted LOIs that were missing information as well as an LOI that was executed with a firm that is not CBE-certified. The firm was given three business (3) days to provide the missing information and replace the non-CBE firm with a CBE firm or provide documentation of its good faith efforts to meet the goal. Waypoint Contracting, Inc. submitted the missing information and an LOI executed with a new CBE firm, to replace the non-CBE firm, within the stipulated timeframe. Waypoint Contracting, Inc. is deemed compliant with the CBE requirements of the solicitation.

Shiff Construction & Development did not include LOIs with its bid submittal. The firm was given three (3) business days within which to provide executed LOIs that meet the established goal or provide documentation of its good faith efforts to meet the goal. Shiff Construction & Development did not submit LOIs that meet the goal or provide documentation of its good faith efforts to meet the goal within the stipulated timeframe. Shiff Construction & Development is deemed non-compliant with the CBE requirements of the solicitation.
