VI. SUMMARY DESCRIPTION: The Broward Sheriff's Office supports this LETF request for matching funds for the Domestic Violence Program 2021-22. BSO has been awarded a grant award in the amount of \$150,000 from the Florida Department of Children and Families. The purpose of the award is to fund Salary and Fringe Benefits for two FTE Detectives in the Criminal Investigations Division to work solely on domestic violence cases. There is a required match in the amount of \$50,000 for a total program cost of \$200,000. The match will be satisfied through a combination of in-kind and cash. The in-kind is satisfied by a portion of the supervising Sergeant (\$10,105.50) and the remaining \$39,894.50 with LETF.
