The following items on the above referenced agenda have been revised to include the following substantive revisions to Exhibit 1:

- 1. Clarified the pricing language in the Item Response Form.
- 2. Added new language for pricing as additional responsiveness criteria in Special Instructions to Vendors.
- 3. Added the Minimum Mandatory Qualifications Attestation Form as additional responsibility criteria in Special Instruction to Vendors. Added language detailing requirements for each criterion.
- 4. Removed language in Scope of Services stating that Health and PBM Service agreements can be awarded to a single proposer even if the individual proposer is not the highest ranked proposer.
- 5. Redefined language in Evaluation Criteria.
- 6. Added exhibit references to the vendor questionnaire.
- 7. Added the Minimum Mandatory Requirements Attestation Form for all of the requirements in the Scope of Service in Special Instruction to Vendors.
- 8. Revised wording related to Arrestee claims processing.
- 9. All instructions will be updated accordingly to reflect the above changes.

These revisions have been conceptually reviewed by the County Auditor's, County Attorney's Offices and Purchasing Division.
