## **RESOLUTION NO. 2020-**

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, CONVEYING CERTAIN PARCELS OF REAL PROPERTY PURSUANT TO SECTION 197.592, FLORIDA STATUTES; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

6 WHEREAS, Broward County ("County") acquired title to certain parcels of real
7 property identified as folio numbers 4842-14-00-0010, 4842-23-00-0153, and
8 5041-16-01-0011 ("Parcels"), each parcel is more particularly described in Exhibit A,
9 attached hereto and made a part hereof, which Parcels escheated to the County by virtue
10 of delinquent ad valorem tax payments in accordance with law;

WHEREAS, Section 197.592(1), Florida Statutes, provides that "[I]ands acquired by any county of the state for delinquent taxes in accordance with law which have not been previously sold or dedicated by the board of county commissioners may, at its discretion, be conveyed to the record fee simple owner of such lands as of the date the county obtained title to the lands. However, before any conveyance shall be made, the former owner of the lands may file with the board of county commissioners a verified written application..." seeking restitution of the Parcels;

18 WHEREAS, the Parcels have not been previously sold or dedicated by the Board19 of County Commissioners of Broward County, Florida ("Board");

WHEREAS, the Board has determined that the Parcels should not be conveyed to the former owners because such owners have not filed a verified written application or petition with the Board seeking the restitution of the Parcels in the manner prescribed by Section 197.592(1), Florida Statutes;

1 WHEREAS, the Board desires to dedicate the Parcels to the County for public 2 purposes; and 3 WHEREAS, the Parcels are further described in Exhibit B designating their current or potential public use, which may change from time to time; NOW, THEREFORE, 4 5 6 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF 7 BROWARD COUNTY, FLORIDA: 8 9 Section 1. The recitals set forth in the preamble to this resolution are true, 10 accurate and deemed as being incorporated by reference herein as though set forth in full hereunder. 11 12 13 Section 2. Pursuant to Section 197.592(1), Florida Statutes, the Board 14 authorizes the conveyance of the Parcels to the County to be used for public purposes. 15 16 Section 3. This Resolution shall be properly recorded in the Public Records of 17 Broward County, Florida upon adoption. 18 19 Section 4. Severability. 20 If any portion of this Resolution is determined by any court to be invalid, the invalid 21 portion will be stricken, and such striking will not affect the validity of the remainder of this 22 Resolution. If any court determines that this Resolution, in whole or in part, cannot be 23 legally applied to any individual, group, entity, property, or circumstance, such 24

## POMPANO BEACH PARCELS

**Parcel 2** – Folio Number 4842-23-00-0153. These two parcels will be retained for maintenance, repair and replacement for County water and sewer lines presently on site and/or such other public use and purpose as may arise from time to time.

## TOWN OF DAVIE PARCEL

**Parcel 3** – Folio Number 5041-16-01-0011. This parcel will be retained since roadway-related infrastructure was installed on this parcel when Pine Island Road Project was completed.
