1 ORDINANCE NO. 2021-2 ORDINANCE OF THE BOARD OF COUNTY AN COMMISSIONERS OF BROWARD COUNTY, FLORIDA. 3 PERTAINING TO THE CODE OF ETHICS FOR ELECTED OFFICIALS AND ALLOWING FOR ELECTED OFFICIALS 4 SERVE AS VOTING MEMBERS OF AUDITOR SELECTION COMMITTEES; AMENDING 5 SECTION 1-19(c)(6) OF THE BROWARD COUNTY CODE OF ORDINANCES ("CODE"); AND PROVIDING FOR 6 SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE. 7 8 (Sponsored by the Board of County Commissioners) 9 10 WHEREAS, Section 218.39, Florida Statutes, requires governmental entities, including cities and counties, to have an annual financial audit performed by an 11 12 independent certified public accountant ("External Auditor") unless the governmental 13 entity is notified in a particular year that it is subject to an audit by the Florida Auditor 14 General; 15 WHEREAS, Section 218.391, Florida Statutes, sets out procedural requirements for the selection of the External Auditor, including a requirement that each city and county 16 17 establishes an auditor selection committee to address selection of an External Auditor to 18 conduct the required audit; 19 WHEREAS, Section 218.391, Florida statutes, was amended in 2019 to require 20 that a member of the board of county commissioners, or designee, serve as a member of 21 a county's auditor selection committee, and that a member of a municipal governing board 22 serve as a member and chair of the municipality's auditor selection committee; 23 WHEREAS, Section 1-19(c)(6) of the Broward County Code of Ordinances 24 prohibits elected officials, defined therein, from serving as voting members of selection or

evaluation committees in connection with any prospective procurement by the elected
 officials' respective governmental entities; and

WHEREAS, the Board of County Commissioners of Broward County, Florida, finds that it is in the public interest to amend Section 1-19(c)(6) of the Broward County Code of Ordinances to allow for elected officials to serve as voting members of auditor selection committees created pursuant to Section 218.391, Florida Statutes, and further finds that addressing this inconsistency between state law (which allows elected officials to serve on such committees) and Section 1-19(c)(6) strengthens the code of ethics,
