**Comments:**

For the purpose of this price analysis and comparison, the unit prices of the low responsive, responsible bidder, Kerner LLC DBA Kerner Environmental were compared to the unit prices of competing firms Sherlock Tree Company, Environmental Quality Inc.

Recommended bidder is \$14,290 greater than one of the bidders that did not comply with CBE participation goals (1.94%). The recommended bidder is \$279,155 greater than the bidder that does not meet licensing requirements. Pricing is reviewed against only the bidders that did not meet CBE goals. The last bidder is \$322,979 greater than the recommended bidder.

Regarding Contracts outside of Broward County:

Broward County Purchasing Division performed due diligence by seeking procurements for the same or similar services. A search was performed on Periscope S2G to identify past non-Broward County contracts of similar scope for price comparison. There were no contracts found with comparable specifications and prices.
