RESOLUTION NO. 2021-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO BROWARD COUNTY'S INDEPENDENT ANNUAL FINANCIAL AUDIT; AMENDING SECTION 18.61 OF THE BROWARD COUNTY ADMINISTRATIVE CODE ("ADMINISTRATIVE CODE"); AMENDING THE REQUIREMENT THAT THE EXTERNAL AUDITOR CHANGE AFTER FIVE YEARS; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE ADMINISTRATIVE CODE, AND AN EFFECTIVE DATE.

WHEREAS, Section 18.61 of the Broward County Administrative Code ("Administrative Code") sets forth the policy for the engagement of external auditors to conduct Broward County's independent annual financial audit ("External Auditor");

WHEREAS, the Broward County Board of County Commissioners ("Board") desires to amend Section 18.61 of the Administrative Code related to the engagement of the External Auditor; and

WHEREAS, the Board finds that the revisions to the Administrative Code as set forth herein are in the best interest of Broward County, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. Section 18.61 of the Broward County Administrative Code is hereby amended to read as follows:

1           **18.61. Independent Annual Audit.**

3           b.     The following policy shall govern the engagement of an auditor for an  
4 independent annual audit of the accounts and financial transactions of Broward County:  
5 As required by Section 218.391, Florida Statutes, the Board of County Commissioners  
6 shall establish an audit committee, in accordance with statutory requirements. The audit  
7 committee shall follow the auditor selection procedures set forth in the statute and shall  
8 rank and recommend auditors in order of preference. The Board of County  
9 Commissioners shall make the final determination in the selection of an auditor. The  
10 engagement of an auditor shall be for a five (5) year term ~~with a mandatory change of~~  
11 ~~auditors after five (5) years.~~

13           Section 2.   Severability.

14           If any portion of this Administrative Code Resolution is determined by any court to  
15 be invalid, the invalid portion will be stricken, and such striking will not affect the validity  
16 of the remainder of this Administrative Code Resolution. If any court determines that this  
17 Administrative Code Resolution, in whole or in part, cannot be legally applied to any  
18 individual, group, entity, property, or circumstance, such determination will not affect the  
19 applicability of this Administrative Code Resolution to any other individual, group, entity,  
20 property, or circumstance.

22           Section 3.   Inclusion in the Broward County Administrative Code.

23           It is the intention of the Board of County Commissioners that the provisions of this  
24 Administrative Code Resolution become part of the Broward County Administrative Code
