

Notice of Public Hearing and Intent to Consider  
Vacating and Abandoning  
A Portion of a 50-Foot Right-of-Way

Notice is hereby given by the Board of County Commissioners, Broward County, Florida, that said Board will hold a Public Hearing at 10:00 A.M., October 19, 2021, in the Broward County Governmental Center, Room 422, 115 South Andrews Avenue, Fort Lauderdale, Florida, to vacate and abandon a portion of that certain 50 foot Right-of-Way for S.E. 2nd Ave. (25 feet of Right-of-Way for S.E. 2nd Ave., "Amended Plat of Enger Park", according to the Plat thereof as recorded in Plat Book 16, Page 44, of the Official Records of Broward County, Florida, and 25 feet of Right-of-Way for Dania Road, "Hallandale Park No. 2" according to the plat thereof as recorded in Plat Book 6, Page 8, of the Official Records of Broward County, Florida), and is located at 118 Southeast 7th Street in the City of Hallandale Beach, Florida. The full legal description and complete text of the proposed release of easement is available for inspection at the Broward County Governmental Center, Planning and Development Management Division, 1 North University Drive, Room 102A, Plantation, Florida.

Interested parties may appear in person or telephonically at the October 19, 2021, meeting of the Broward County Board of County Commissioners and be heard with respect to this public hearing item.
