Prime Contractor: DP Development of the Treasure Coast, LLC

The Office of Economic and Small Business Development (OESBD) has evaluated DP Development of the Treasure Coast, LLC's CBE participation for the General Roadway and Miscellaneous Construction. This contract was awarded to DP Development of the Treasure Coast, LLC on March 15, 2019 for a three-year potential estimated amount of \$34,374,210. The Highway and Bridge Maintenance Division (HBMD) is requesting a \$2 million threshold increase to perform emergency work countywide and address several severe pavement failures due to the flooding caused by tropical storm ETA, including Andrews Avenue at Prospect Road and NW 6th Avenue between Commercial Blvd and Oakland Park Blvd. This review is based on information provided by the requesting agency and the prime contractor, DP Development of the Treasure Coast, LLC. The overall CBE goal for this contract is 30% and DP Development of the Treasure Coast, LLC's commitment is 30.2%. An overview is provided as follows:
