ADDS A NEW FTZ APPLICATION AND PROVIDES FEE, GENERAL UPDATES TO TARIFF TEXT; AND PROVIDING SEVERABILITY, FOR **INCLUSION** IN THE ADMINISTRATIVE CODE, AND AN EFFECTIVE DATE.
