SUBJECT: LETF REQUEST

BSO Port Everglades has been awarded \$200,000 in FY21 Port Security Grant Program (PSGP) to purchase two (2) new outboard engines; current engine hours will surpass industry engine standards. Attached is a recent quote from Yamaha for the new motors. The remaining funds will be utilized to maintain the engines on the other vessels, repair/service the generators, as well as, perform any needed upgrade to the marine electronics or vessel motors.

We are requesting approval to utilize \$50,000 from the local funds of the Law Enforcement Trust Funds (LETF) to cover the 25% match for FY21 PSGP grant. The latest LETF spreadsheet shows \$363,613.10 currently available.
