RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY. FLORIDA, AUTHORIZING APPROPRIATION AND DISBURSEMENT OF **CHILDREN** DEPARTMENT FLORIDA FAMILIES GRANT FUNDS IN THE AMOUNT OF \$420,162 TO PROVIDE EMERGENCY SHELTER SERVICES, RAPID REHOUSING SERVICES, AND SUPPORTIVE SERVICES INDIVIDUALS **FAMILIES** AND **EXPERIENCING** AND **SERVICES HOMELESSNESS** ADMINISTRATIVE YEAR 2020-2021: FISCAL **AUTHORIZING** COUNTY ADMINISTRATOR TO TAKE ALL NECESSARY **BUDGETARY** ADMINISTRATIVE AND **ACTIONS** IMPLEMENT AGREEMENTS WITH CURRENT SERVICE PROVIDERS: AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Florida Department of Children and Families ("DCF") has awarded Broward County three-year funding for four (4) local projects benefitting families and individuals experiencing homelessness in Broward County, and for administrative services to assist in increasing the capacity of the Continuum of Care;

WHEREAS, on June 11, 2019, the Board of County Commissioners of Broward County, Florida ("Board"), provided Fiscal Year 2019-2020 DCF funds in the amount of Four Hundred Twenty Thousand One Hundred Sixty-two Dollars (\$420,162) to specified service providers for emergency shelter services, rapid rehousing services, and supportive services to families and individuals experiencing homelessness, and for administrative services (collectively, the "Services") for Fiscal Year 2019-2020;

WHEREAS, the Board desires to provide the second year of DCF funding in the amount of Four Hundred Twenty Thousand One Hundred Sixty-two Dollars (\$420,162) to the current service providers listed in Attachment A for the provision of the Services for

WHEREAS, the Board finds that the Services benefit the residents of Broward County and serve a public purpose, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. Authorized Appropriation and Disbursement.

The Board hereby authorizes appropriation and disbursement of funds in the aggregate amount of Four Hundred Twenty Thousand One Hundred Sixty-two Dollars (\$420,162) to the service providers listed in Attachment A for Fiscal Year 2020-2021, beginning July 1, 2020, and ending June 30, 2021.

Section 2. Administrative Action by the County Administrator.

The County Administrator is hereby authorized to take all necessary administrative and budgetary actions to implement the renewed agreements with the current service providers. Any material deviations from the approved agreement must be presented to the Board for approval.

Section 3. Severability.

If any portion of this Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Resolution. If any court determines that this Resolution, in whole or in part, cannot be
