Investments not listed in this Agreement Article are not approved for funding under this award.

Investment 2: CCTV camera lifecycle replacement is fully funded for \$382650.

Investment 3: PEV security storage area data network server upgrade is fully funded for \$440161.

#### **Article II - Activities Conducted Abroad**
