

Tax Equity and Fiscal Responsibility Act ("TEFRA") Minutes

Multifamily Housing Revenue Bonds – Federation Davie Apartments

An advertised ("TEFRA") Public Hearing for Federation Davie Apartments (the "Development") was held by the Housing Finance Authority of Broward County, Florida, on Wednesday, June 24, 2020, at 9:30 a.m., telephonically due to the COVID-19 Pandemic at 110 NE 3rd Street, Suite 300, Fort Lauderdale, Florida, in reference to the Multifamily Housing Revenue Bonds.

The meeting was called to order by the Executive Director, Ralph Stone at 9:30 a.m.

Mr. Stone announced a public hearing was being held by the Housing Finance Authority of Broward County, Florida, for the purpose of receiving comments and hearing discussion concerning the proposed issuance by the Authority of its Multifamily Housing Mortgage Revenue Bonds ("the Bonds), in an aggregate principal amount of not to exceed \$22,000,000 in one or more series, to provide financing for the acquisition, rehabilitation and equipping for multifamily residential rental facilities known as Federation Davie Apartments consisting of approximately 80 units located on approximately 4.5 acres at 5701 SW 82nd Avenue, Davie, Florida, to be occupied by persons of low to moderate income and owned and operated by Federation Davie Preservation LP, a Florida Limited Partnership, or an entity related to such partnership.

Mr. Stone opened the public hearing concerning the proposed issuance by the Authority of its Multifamily Housing Mortgage Revenue Bonds (the "Bonds").

Mr. Stone mentioned the public hearing was conducted pursuant to Section 147(f) of the Internal Revenue Code of 1986, as amended, with respect to the proposed issuance by the Authority of its Bonds. A transcript of the testimony given at this public hearing will be provided to the Board of County Commissioners of Broward County at a regular meeting of the Commission, at which time the Commission will, for purposes of complying with the Code, approve or disapprove the issuance of the Bonds by the Authority.

Mr. Howard presented the Affidavit of Publication of Notice of the public hearing, published on Wednesday, June 10, 2020, in the Sun-Sentinel, and directed that it become part of the TEFRA Minutes as Exhibit "A". The presentation of notice sufficed to cover all hearings undertaken for Federation Davie Apartments.

Mr. Stone inquired of the audience who wished to be heard concerning the proposed issuance by the Authority of its Multifamily Housing Mortgage Revenue Bonds to provide financing for the acquisition, rehabilitation and equipping for multifamily residential rental facilities known as Federation Davie Apartments (the "Development").

The meeting was adjourned at 9:35 a.m.
