1 **RESOLUTION NO. 2021-**2 RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA. 3 DESIGNATING A PORTION OF NW SIXTH COURT IN THE BROWARD MUNICIPAL SERVICES DISTRICT ("COUNTY 4 ROAD") IN HONOR OF JUDGE ZEBEDEE WRIGHT AND DR. KATHLEEN C. WRIGHT; DIRECTING THE COUNTY 5 ADMINISTRATOR TO TAKE ANY NECESSARY ACTIONS TO EFFECTUATE THE RENAMING OF THE COUNTY 6 ROAD; DIRECTING THE COUNTY ADMINISTRATOR TO PROVIDE A COPY OF THIS RESOLUTION TO THE 7 OFFICIALS DESIGNATED HEREIN; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE. 8 9 (Sponsored by Commissioner Barbara Sharief) 10 WHEREAS, Judge Zebedee Wright ("Judge Wright") has made numerous 11 12 significant contributions to the County, including as a civil rights attorney and Broward 13 County Court Judge; 14 WHEREAS, Dr. Kathleen C. Wright ("Dr. Wright") was a champion of education 15 and made history as the first African-American woman to win a countywide election in the 16 State of Florida, the first African-American woman in the state to serve on a school board. 17 and the first African-American member of The School Board of Broward County; 18 WHEREAS, that portion of NW 6th Court from NW 27th Avenue to NW 31st 19 Avenue is a County-owned road located in the Broward Municipal Services District 20 ("County Road"); 21 WHEREAS, pursuant to Section 336.05, Florida Statutes, the Board of County Commissioners ("Board") is authorized to name and rename County-owned streets and 22

roads;

WHEREAS, Section 18.43 of the Broward County Administrative Code ("Administrative Code") sets out the policy of the Board for naming property owned by Broward County ("County");

WHEREAS, on April 20, 2021 (Board Agenda Item No. 38), the Board (1) provided notice on the record that the Board would consider the proposed designation of the County Road in honor of Judge Wright and Dr. Wright, as required by Section 18.43(h) of the Administrative Code; (2) waived Section 18.43(c) of the Administrative Code, which provides that property owned by the County should not be named after living persons, in order to rename the County Road after Judge Wright, a living person; and (3) directed the County Administrator to solicit the input of at least three local municipalities, homeowners' associations, or community groups of the Board's proposed renaming of the County Road, which correspondence is attached hereto as Attachment 1; and

WHEREAS, in recognition of the contributions of Judge Wright and Dr. Wright, the Board desires to designate the County Road in honor of Judge Wright and Dr. Wright, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

- Section 1. The Board hereby renames the County Road in honor of Judge Wright and Dr. Wright. In accordance with Section 18.43(g) of the Administrative Code, the current name of the County Road shall be retained as a secondary designation.
- Section 2. The Board directs the County Administrator, as Clerk of the Board, to transmit a copy of this Resolution to the United States Postal Service, the Broward

3	Section 3. The Board further directs the Broward County Administrator to take
4	all budgetary and other actions necessary to effectuate the renaming of the County Road.
5	Section 4. <u>Severability</u> .
6	If any portion of this Resolution is determined by any court to be invalid, the invalid
7	portion will be stricken, and such striking will not affect the validity of the remainder of this
8	Resolution. If any court determines that this Resolution, in whole or in part, cannot be
9	legally applied to any individual, group, entity, property, or circumstance, such
10	determination will not affect the applicability of this Resolution to any other individual,
11	group, entity, property, or circumstance.
12	Section 5. <u>Effective Date</u> .
13	This Resolution is effective upon adoption.
