The Office of Economic and Small Business Development (OESBD) has conducted an evaluation of MBR Construction Inc.'s CBE Participation for Contract No. PNC2119056C1- Everglades Holiday Park Site Improvements. This evaluation is for Change Order Nos. 4 and 5. The overall CBE goal for this contract is 25% and MBR Construction Inc.'s CBE commitment is 34.4%. An overview in provided as follows:

Compliance Comments:

MBR Construction, Inc. has achieved 28.2% and is short of their commitment by 6.2% as of this date. Per this evaluation, OESBD requested and received a plan of action from MBR Construction, Inc. to address their CBE commitment deficit for the duration of the contract. MBR Construction, Inc. informed OESBD that the project schedule was delayed due to site flooding which affected the work scope being performed by their CBE subcontractor, Betancourt Construction, Inc. OESBD has confirmed this information with the Parks and Recreation Division. The project is currently at 41% completion. OESBD will continue to monitor this project for compliance.
