

RESOLUTION NO. 2020-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, AUTHORIZING THE FILING OF AN AMENDED APPLICATION FOR FEDERAL ASSISTANCE FOR FEDERAL FISCAL YEAR 2019 WITH THE FEDERAL TRANSIT ADMINISTRATION (FTA) PURSUANT TO 49 U.S.C. SECTION 5339, BUS AND BUS FACILITIES FORMULA GRANTS, INCREASING IT BY FIFTEEN THOUSAND TWENTY ONE DOLLARS (\$15,021) FOR A NEW TOTAL AMOUNT UP TO THREE MILLION THREE HUNDRED NINETY-FOUR THOUSAND FOUR HUNDRED THIRTY-THREE DOLLARS (\$3,394,433) UNDER THE FEDERAL TRANSIT ACT; AUTHORIZING THE DIRECTOR OF THE TRANSPORTATION DEPARTMENT TO FURNISH FTA WITH ANY ADDITIONAL INFORMATION WHICH MAY BE REQUIRED; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ANY NECESSARY ADMINISTRATIVE OR BUDGETARY ACTIONS TO ACCEPT THE GRANT FUNDING; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Secretary of the U.S. Department of Transportation (USDOT) is authorized to award grants for transit projects;

WHEREAS, Broward County has the authority to apply for and accept grant awards made by the USDOT as authorized by the Federal Transit Administration Act of 1964;

WHEREAS, the City of Fort Lauderdale was awarded Federal Transit Administration (FTA) Urbanized Area Formula Funds and Bus and Facilities Formula Grant funds for fiscal year 2019;

WHEREAS, the City of Fort Lauderdale has requested that Broward County accept the funds previously allocated, and use the funds to supplement capital investments; and

1 WHEREAS, it is required by the U.S. Department of Transportation, in
2 accordance with the provisions of Title VI of the Civil Rights Act of 1964, that in
3 connection with the filing of an application for assistance under the Federal Transit Act,
4 as amended, the applicant give an assurance that it will comply with Title VI of the Civil
5 Rights Act of 1964, and applicable requirements of the U.S. Department of
6 Transportation, NOW, THEREFORE,

8 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF

11 Section 1. That the Broward County Board of County Commissioners
12 authorizes amending the FY2019 grant application with the U.S. Department of
13 Transportation pursuant to 49 U.S.C. Section 5339 of the Federal Transit Act, Bus and
14 Bus Facilities Formula Grants, adding an additional Fifteen Thousand Twenty-one
15 Dollars (\$15,021) for a new total amount up to Three Million Three Hundred Ninety-four
16 Thousand Four Hundred Thirty-three Dollars (\$3,394,433), to be appropriated as
17 follows:
