ADOPT VACATION OF A 15-FOOT DRAINAGE EASEMENT LYING WITHIN LOTS 3 AND 4, BLOCK 7 OF LITTLE HARBOR ON THE HILLSBORO SEC 4 (PLAT BOOK 49, PAGE 25); VACATION PETITION NO. 2020-V-01; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to a Notice of Public hearing, duly and regularly advertised

in accordance with law, a public hearing was held in the Commission Meeting Room No. 422, Broward County Governmental Center located at 115 South Andrews Avenue, Fort Lauderdale, Florida, on Tuesday, December 8, 2020 at 10:00 A.M., to consider the advisability of renouncing and disclaiming the rights of the County and the public and to vacate and abandon, discontinue, and close a 15-foot drainage easement lying within lots 3 and 4, block 7 of Little Harbor on the Hillsboro Section 4 Plat, as recorded in Plat Book 49, Page 25 of the Public Records of Broward County and is located at 64 Northeast 11 Way in the City of Deerfield Beach, said lands situate, being and lying in Broward County, Florida, described as follows:

WHEREAS, after hearing all interested parties and determining that the proposed action will not materially interfere with the County road system or adversely affect the interests of the citizens of Broward County, and will not affect the ownership of or deprive any person convenient access to his/her premises, in accordance with the Florida

Statutes (as amended from time to time) it was determined that it would be in the best interest of all concerned to renounce, disclaim, release, vacate and abandon the rights of the County and the public to and in the aforementioned land as described in Exhibit A attached hereto, all situate, lying and being in Broward County, Florida, NOW, THEREFORE,

BE IT RESOLVED by the Board of County Commissioners of Broward County, Florida ("Board") that:

Section 1. Vacation and Abandonment.

Said Board hereby renounces, disclaims, releases, and abandons the right(s) of the County and the public to the land as described in Exhibit A, all situate, lying and being in Broward County, Florida.

Section 2. Severability.

If any portion of this Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Resolution. If any court determines that this Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Resolution to any other individual, group, entity, property, or circumstance.


