A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO THE ENVIRONMENTAL PROTECTION AND GROWTH MANAGEMENT DEPARTMENT, ENVIRONMENTAL AND CONSUMER PROTECTION DIVISION; AMENDING SECTION 40.50 OF THE BROWARD COUNTY ADMINISTRATIVE CODE ("ADMINISTRATIVE CODE"), TO ESTABLISH FEES FOR LOCKSMITH AND APPRENTICE LOCKSMITH LICENSES AND LOCKSMITH BUSINESS REGISTRATION CERTIFICATES; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE ADMINISTRATIVE CODE, AND AN EFFECTIVE DATE.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. Section 40.50 of the Broward County Administrative Code is hereby amended to read as follows:

40.50. Environmental and Consumer Protection Fee Schedule.

i. *Application Fees for Licenses for Locksmiths and Apprentice Locksmiths and for Registration of Locksmith Businesses.* The Broward County Board of County Commissioners hereby determines, establishes, and fixes the following fees:

	<i>Fees</i>
1. Locksmith license or renewal.....	\$120.00
2. Apprentice locksmith license or renewal.....	40.00
3. Locksmith business registration or renewal.....	505.00 per location

11 It is the intention of the Board of County Commissioners that the provisions of this
12 Administrative Code Resolution become part of the Broward County Administrative Code
13 as of the effective date. The sections of this Administrative Code Resolution may be
14 renumbered or relettered and the word "resolution" may be changed to "section," "article,"
15 or such other appropriate word or phrase to the extent necessary in order to accomplish
16 such intention.
