Howard,

I have had an opportunity to review materials relative to Plat No. 029-MP-21/GITTA-GANPAT; Broward County property folio(s): 494225050160.

A. In my capacity as the County's archaeological consultant, based on the available information including archival documents, maps, the Broward County Land Use Plan and the Florida Master Site File (FMSF), it is my determination that the proposed project could have an adverse effect on an unrecorded resource.

The subject property contains a structure over 50 years old. The structure at this location was built in 1955. The structure is a motel that exhibits Mid-Century architectural style. The structure appears to retain its integrity of plan and design. Additionally, its setting on a commercial strip has been retained. The plat application indicates that this structure will be demolished. As the County Archaeological Consultant, I recommend it be reviewed and recorded with the FMSF.

B. The subject property is located within the City of Fort Lauderdale outside jurisdiction of the Broward County historic preservation ordinance (B.C. Ord. 2014-32). The property owner / agent is advised to contact the municipality to seek project review for compliance with municipal historic preservation regulations.

Such activity shall not resume unless specifically authorized by the district medical examiner or State Archaeologist."
