The Office of Economic and Small Business Development (OESBD) has conducted a review of Chen Moore and Associates, Inc.'s CBE participation as of December 9, 2019. This contract was awarded to Chen Moore and Associates, Inc. on September 15, 2016 to provide engineering services during the design and post-design phases of the contract. The proposed amendment is to increase fees for additional design services required to complete the contract. Chen Moore and Associates, Inc.'s CBE commitment remains at 28% for the first amendment thru the duration of the contract. An overview is provided as follows:
