

RESOLUTION NO.

1 A RESOLUTION OF THE BOARD OF COUNTY
2 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
3 URGING GOVERNOR DESANTIS, THE FLORIDA
4 DEPARTMENT OF EDUCATION, AND THE STATE BOARD
5 OF EDUCATION TO REINSTATE THE ADMINISTRATION
6 OF THE YOUTH RISK BEHAVIOR SURVEILLANCE
7 SYSTEM; DIRECTING TRANSMISSION OF THIS
8 RESOLUTION TO THE OFFICIALS DESIGNATED HEREIN;
9 AND PROVIDING FOR SEVERABILITY AND AN
10 EFFECTIVE DATE.

12 WHEREAS, the Youth Risk Behavior Surveillance System (also known as the
13 Youth Risk Behavior Survey) ("YRBSS") is a Statewide, school-based confidential survey
14 of Florida's public high school students;

15 WHEREAS, the YRBSS includes questions that address sexual and physical
16 abuse, bullying, eating disorders, and gender identity;

17 WHEREAS, the purpose of the YRBSS is to monitor priority health-risk behaviors
18 that contribute substantially to the leading causes of death, disability, and social problems
19 among youth, continuing to patterns in adulthood;

20 WHEREAS, the first Florida YRBSS was administered in 1991;

21 WHEREAS, with the understanding that students sometimes feel unheard or are
22 nervous to approach a school official about an issue, mental health advocates have relied
23 on the data of the YRBSS to identify needs and disparities;

24 WHEREAS, the YRBSS can aid in providing data to address the rising rates of
suicide attempts and ideations, particularly among young girls, the LGTBQI community,
and other underrepresented communities;

1 WHEREAS, since 2001, the YRBSS has been jointly administered in
2 odd-numbered years by the Florida Department of Health and the Florida Department of
3 Education;

4 WHEREAS, in 2001, the YRBSS became part of the Florida Youth Survey that
5 includes the Florida Youth Tobacco Survey, the Middle School Health Behavior Survey,
6 and the Florida Youth Substance Abuse Survey;

7 WHEREAS, the YRBSS has been supported by many agencies, including the
8 Florida Departments of Education, Children and Families, and Juvenile Justice; school
9 districts throughout the State; and the Division of Adolescent and School Health at the
10 Centers for Disease Control and Prevention; and

11 WHEREAS, the Florida Department of Education has recently withdrawn its
12 participation in the YRBSS, NOW, THEREFORE,

14 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
15 BROWARD COUNTY, FLORIDA:

17 Section 1. The Broward County Board of County Commissioners ("Board")
18 urges Governor DeSantis, the Florida Department of Education, and the State Board of
19 Education to reinstate the administration of the YRBSS, in recognition of the vital role that
20 the YRBSS plays in monitoring priority health-risk behaviors that contribute substantially
21 to the leading causes of death, disability, and social problems among youth, continuing
22 to patterns in adulthood.

23 Section 2. The Board directs the County Administrator to transmit a copy of this
24 Resolution to Governor DeSantis; the Florida Department of Education; successor

1 Commissioner of Education Manny Diaz, Jr., appointee effective June 1, 2022; State
2 Board of Education Chair Thomas Grady; State Board of Education Vice Chair Benjamin
3 Gibson; and to each member of the State Board of Education.

4 Section 3. Severability.

5 If any portion of this Resolution is determined by any court to be invalid, the invalid
6 portion will be stricken, and such striking will not affect the validity of the remainder of this
7 Resolution. If any court determines that this Resolution, in whole or in part, cannot be
8 legally applied to any individual, group, entity, property, or circumstance, such
9 determination will not affect the applicability of this Resolution to any other individual,
10 group, entity, property, or circumstance.

11 Section 4. Effective Date.

12 This Resolution is effective upon adoption.
