1 **RESOLUTION NO. 2021-**2 RESOLUTION OF THE BOARD OF COUNTY OF BROWARD COUNTY, COMMISSIONERS FLORIDA. 3 SUPPORTING THE RIGHT OF THE STATE OF ISRAEL TO USE ALL APPROPRIATE AND NECESSARY MEANS TO 4 DEFEND ITSELF FROM ROCKET ATTACKS INCLUDING ON THE ISRAELI CIVILIAN POPULATION, SUPPORTING 5 ISRAEL'S RIGHT TO LIVE IN PEACE AND SECURITY, AND RESOLUTION SUPPORTING PROMPT OF THE Α 6 CURRENT FIGHTING; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE. 7 (Sponsored by Commissioner Mark D. Bogen) 8 9 10 WHEREAS, Hamas exercises control over the Gaza Strip, an area of land Israel 11 had captured in 1967 in a defensive war and from which Israel fully withdrew in 2005; 12 WHEREAS, we are witnessing an escalation of hostilities between Israel and 13 Hamas, precipitated by the firing by Hamas and other Gaza-based terrorist groups of 14 thousands of rockets into the State of Israel, indiscriminately targeting civilians and 15 resulting in civilian deaths and other casualties; 16 WHEREAS, Israel, acting well within its rights as a sovereign nation, has 17 responded to these attacks including through aerial counterattacks targeting structures 18 used in connection with the launching of rockets into Israel; 19 WHEREAS, it is Israeli practice to provide advance notice to civilian occupants of 20 these structures that the structures will be targeted, giving those occupants an opportunity 21 to vacate the structures; 22 WHEREAS, every sovereign nation, including Israel, has the right to defend its 23 residents from attacks of the nature we are currently witnessing, and no responsible 24

nation would permit such attacks to occur without responding in a manner designed to
 promptly end such attacks and deter similar attacks in the future;

WHEREAS, this tragic loss of civilian life can be avoided only if Hamas and aligned
terrorist groups cease firing rockets into Israel; and

5 WHEREAS, the Board of County Commissioners ("Board") strongly supports the
6 sovereignty of the State of Israel, and recognizes its right to self-defense and to protect
7 its citizens, NOW, THEREFORE,

9 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF10 BROWARD COUNTY, FLORIDA:

Section 1. The Board strongly supports the right of the State of Israel, as a
sovereign nation, to defend itself and its residents against attacks of the nature we are
currently witnessing, and the right of the State of Israel and its residents to live in peace
and security free from such attacks.

17 Section 2. The Board expresses its hope for a prompt cessation of this current18 fighting.

20 Section 3. <u>Severability</u>.

If any portion of this Resolution is determined by any court to be invalid, the invalid
portion will be stricken, and such striking will not affect the validity of the remainder of this
Resolution. If any court determines that this Resolution, in whole or in part, cannot be
legally applied to any individual, group, entity, property, or circumstance, such
