RE: Agenda Item No.95 Commission Meeting of April 6, 2021 -Renaming NW 7th Street in honor of Harry T. and Harriette Moore, and Proposal to rename NW 6th Court in honor of Congressman Alcee L. Hastings (Agenda Item No. 65, February 23, 2021)

On March 24, 2021, Planning and Development Management Division hosted a virtual community meeting to solicit input on the proposed renaming of NW 7th Street and NW 6th Court, as noted above. Since that time, staff understands that Commissioner Holness' original item to rename NW 6th Court for Congressman Alcee L. Hastings is being withdrawn and he has replaced it with Agenda Item No. 96 on the April 6th Commission Meeting, to consider renaming NW 8th Street in his honor. Additionally, Commissioner Sharief has submitted Item No. 93 on the April 6th Commission Meeting to consider renaming NW 7th Court in honor of Congressman Alcee L. Hastings.

Staff notified affected property owners on those streets, by mail, and invited interested parties to attend the meeting and to submit comments. Attached are the responses that have been received on the proposed renaming.
