(5) All passenger check-in facilities must be reserved in advance, with the approval of the Aviation Department. Passenger check-in facilities charges shall be applied at the rate of twenty-five dollars (\$25.00) per hour, or any part thereof, for Signatory

Carriers, and thirty-three dollars (\$33.00) thirty-two dollars (\$32.00) per hour, or
any part thereof, for all other carriers, per ticket counter position for any passenger
check-in facility reserved, whether utilized or not. Signatory Carriers will not be
charged, on a monthly basis, for per use passenger check-in facilities in an amount
greater than would otherwise be charged to that carrier for a monthly preferential
lease of equivalent ticket counter space.
