

RESOLUTION NO. 2020-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, AUTHORIZING THE FILING OF AN AMENDED APPLICATION FOR FEDERAL ASSISTANCE FOR FEDERAL FISCAL YEAR 2020 WITH THE FEDERAL TRANSIT ADMINISTRATION (FTA) PURSUANT TO 49 U.S.C. SECTION 5307, AN ADDITIONAL FOUR HUNDRED THOUSAND SEVEN HUNDRED THIRTY-TWO DOLLARS (\$400,732) FOR A NEW TOTAL AMOUNT UP TO TWENTY-SEVEN MILLION NINE HUNDRED THIRTY-NINE THOUSAND ONE HUNDRED TWENTY-NINE DOLLARS (\$27,939,129); AUTHORIZING THE DIRECTOR OF THE TRANSPORTATION DEPARTMENT TO FURNISH FTA WITH ANY ADDITIONAL INFORMATION WHICH MAY BE REQUIRED; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ANY NECESSARY ADMINISTRATIVE OR BUDGETARY ACTIONS TO ACCEPT THE GRANT FUNDING; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Secretary of the U.S. Department of Transportation (USDOT) is authorized to award grants for transit projects;

WHEREAS, Broward County has the authority to apply for and accept grant awards made by the USDOT;

WHEREAS, several municipalities were awarded grant funds for fiscal years 2016, 2017, and 2018; and

WHEREAS, those municipalities have requested that Broward County accept the funds previously allocated, and use the funds to supplement capital investments, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. The Board of County Commissioners of Broward County, Florida, authorizes amending the FY2020 grant application with the U.S. Department of

1 Transportation pursuant to 49 U.S.C. Section 5307, of the Federal Transit Act, Bus and Bus
2 Facilities Formula Grants, to aid in the financing of capital assistance projects an additional
3 Four Hundred Thousand Seven Hundred Thirty-two Dollars (\$400,732), for a new total
4 amount up to Twenty-seven Million Nine Hundred Thirty-nine Thousand One Hundred
5 Twenty-nine Dollars (\$27,939,129); to be appropriated as follows:

8 Capital and Preventive Maintenance..... \$400,732

9 TOTAL APPROPRIATIONS..... \$400,732

10 Section 2. The Director of the Transportation Department, or designee, is hereby
11 authorized to furnish all information that the U.S. Department of Transportation may require
12 in connection with the application.

13 Section 3. The Board authorizes the County Administrator to take all necessary
14 administrative and budgetary actions to implement the grant.

15 Section 4. Effective Date.
