1 **RESOLUTION NO.** 2 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD 3 COUNTY, FLORIDA, PERTAINING TO ADDITIONAL ADJUSTMENTS TO VOTING 4 PRECINCTS PURSUANT TO SECTION 101.001, FLORIDA STATUTES; DIRECTING THE 5 COUNTY ADMINISTRATOR TO TRANSMIT A CERTIFIED COPY OF THIS RESOLUTION 6 TO THE SUPERVISOR OF ELECTIONS; AND PROVIDING FOR SEVERABILITY AND AN 7 EFFECTIVE DATE. 8 9 WHEREAS, Section 101.001(1), Florida Statutes, requires approval of the Board of 10 Broward County Commissioners ("Board"), upon recommendation and approval of the 11 Broward County Supervisor of Elections ("SOE"), to alter voting precincts in Broward County; 12 WHEREAS, on May 24, 2022, at the recommendation of the SOE and pursuant to 13 Section 101.001(1), Florida Statutes, the Board adopted Resolution No. 2022-293, approving 14 adjustments to Broward County's voting precincts and a new precinct map; 15 WHEREAS, based on the administration of the August 2022 Primary Election with the 16 new precincts, the SOE finds that certain additional adjustments are necessary; and 17 WHEREAS, pursuant to Section 101.001(1), Florida Statutes, the SOE recommends 18 and approves further modifying the County's voting precincts as indicated in Exhibit A 19 attached hereto, NOW, THEREFORE, 20 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD 21 COUNTY, FLORIDA:

Section 1. Based on the recommendation and approval of the SOE, and pursuant
to Section 101.001, Florida Statutes, the Board hereby approves the revised Broward County
voting precincts set forth in Exhibit A attached hereto.

Section 2. The Board directs the County Administrator to provide a certified copy
of this Resolution to the SOE.

If any portion of this Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Resolution. If any court determines that this Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Resolution to any other individual, group, entity, property, or circumstance.

utilized commencing with the November 2022 General Election.


