Operational Compatibility - When replacement parts from alternate suppliers are not interchangeable with original part and causes equipment incompatibility.

Follow-On - Potential for continued development or enhancement with same supplier in future eliminates costs incurred by using different supplier.

Complies with existing community and safety standards.

Economic Consideration - include price justification and how prices are fair and reasonable.

Competitive solicitation deemed impractical.

Ease of Maintenance - When costs associated with maintenance or retooling prohibits competition.

Prevents Time Delays - Indicate that product delivery will affect program/project delivery. Must be verified by specific need dates and program schedules.

Other - Demonstrate how sole source, sole brand purchase benefits the County.

Johnson Controls, Inc. (JCI) has proprietary systems, components and software serving various County facilities and is the only vendor authorized to provide this service. This includes JCI P2000 and C.Cure 9000 security access and peripherals, Integrated Fire Controls (IFC) fire alarm and related peripherals. All JCI technicians receive OEM factory training. All the JCI equipment communicate and operate through centralized JCI database systems which allow for remote access and control by County personnel (essential for maintaining security and life safety). There is currently no other equipment on the market that can be used to replace JCI proprietary equipment and systems. If any other manufacturer's equipment is purchased, the expense for an entirely new Security Access Control and Life Safety System would be required.
