These rules and regulations are promulgated in accord with the provisions of the Broward County Land Use Plan.

#### 1.5 EFFECTIVE DATE OF AN AMENDMENT TO THE BROWARD COUNTY LAND USE PLAN

An amendment to the Broward County Land Use Plan shall take effect on the latter date of the following: as provided by law, the date that any applicable declaration of restrictive covenants is recorded or the date that the municipal amendment is recertified. The local government's zoning shall comply with the plan amendment. Nothing therein shall prohibit a local government from adopting more restrictive zoning than provided for by the permitted uses of the Broward County Land Use Plan, as amended, or a certified local land use plan.
