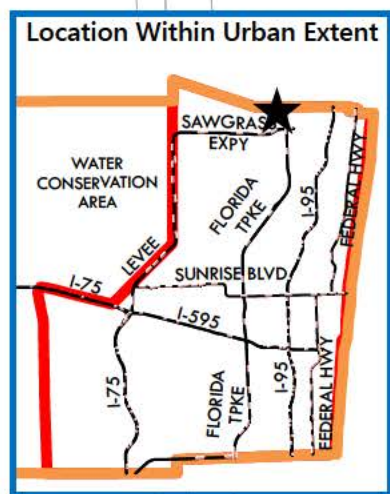
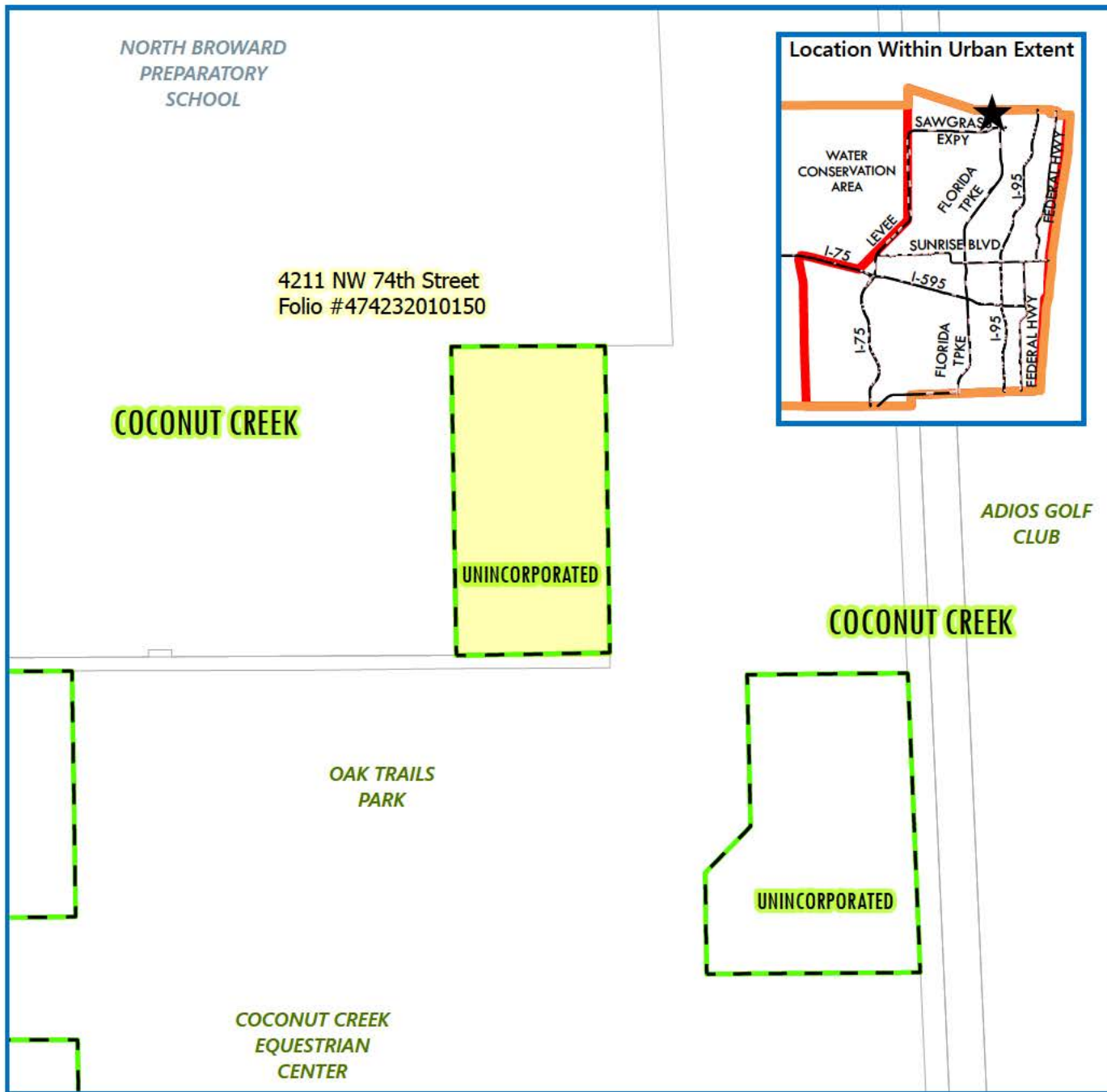
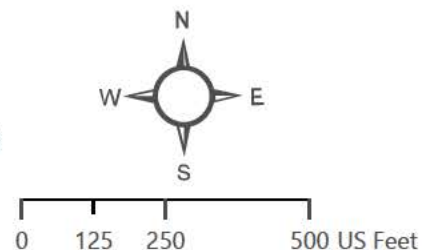




# Rezoning 1-Z-22 Site Location Map

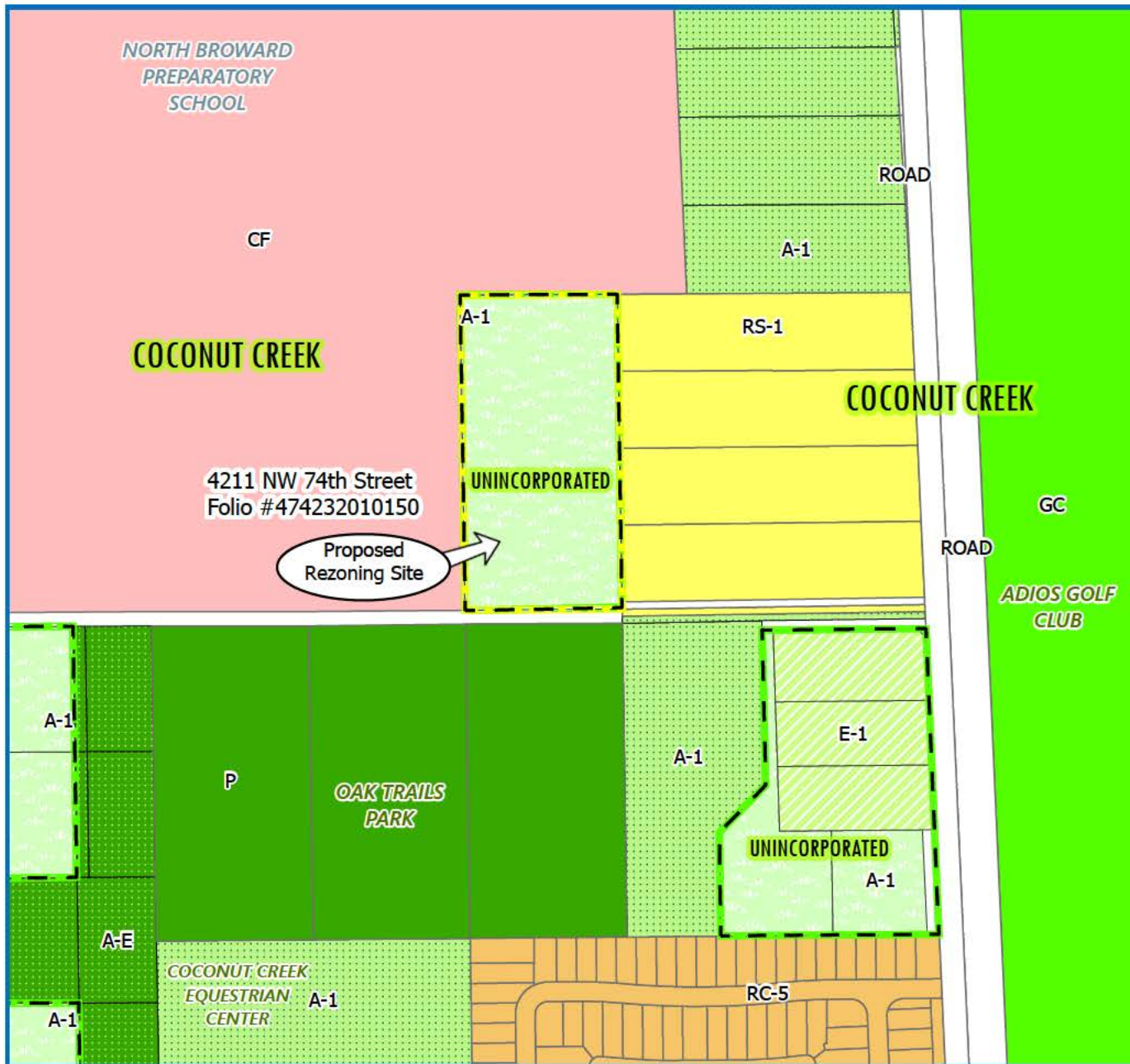

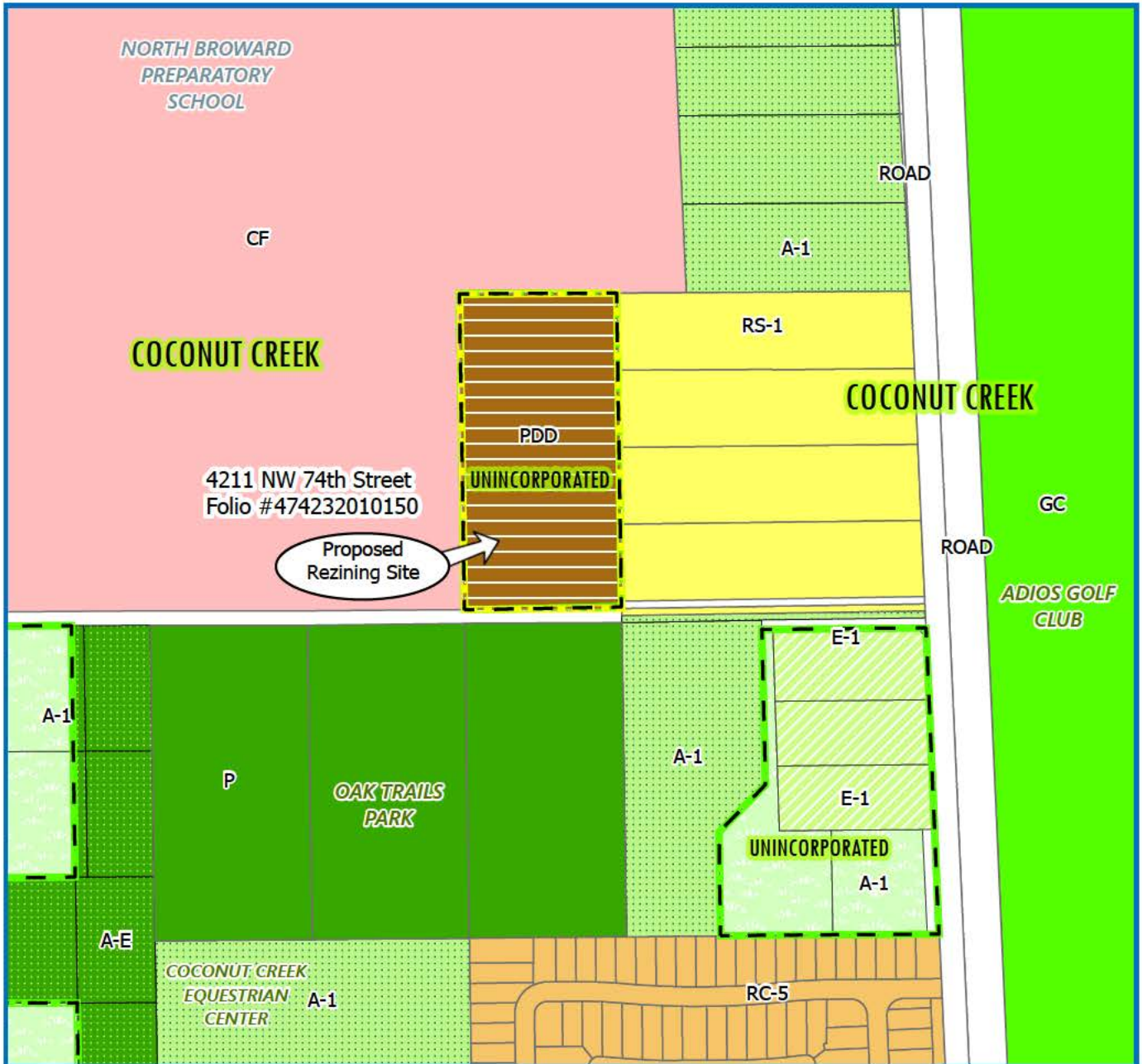

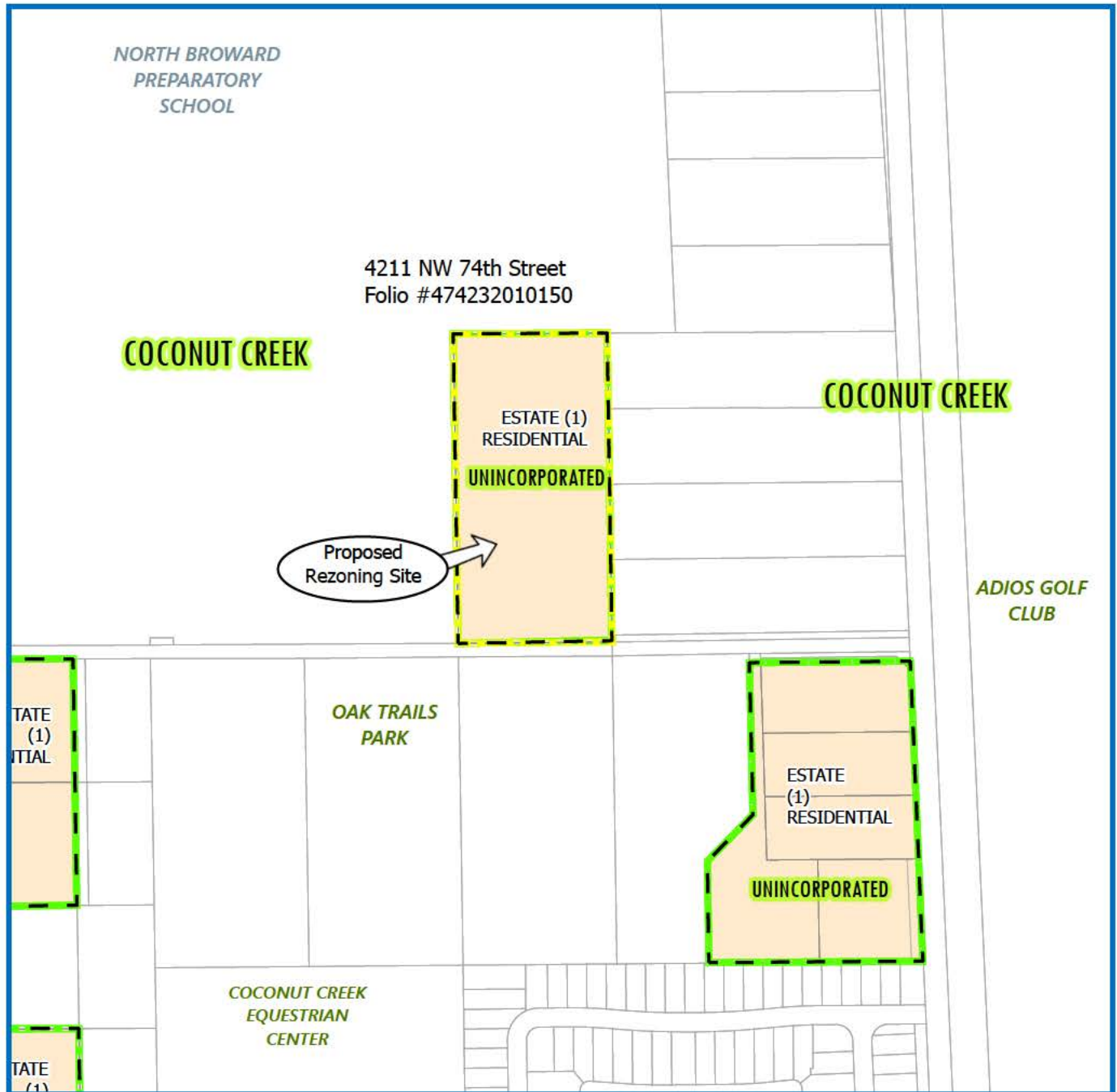

Broward Municipal Services District Future Land Use



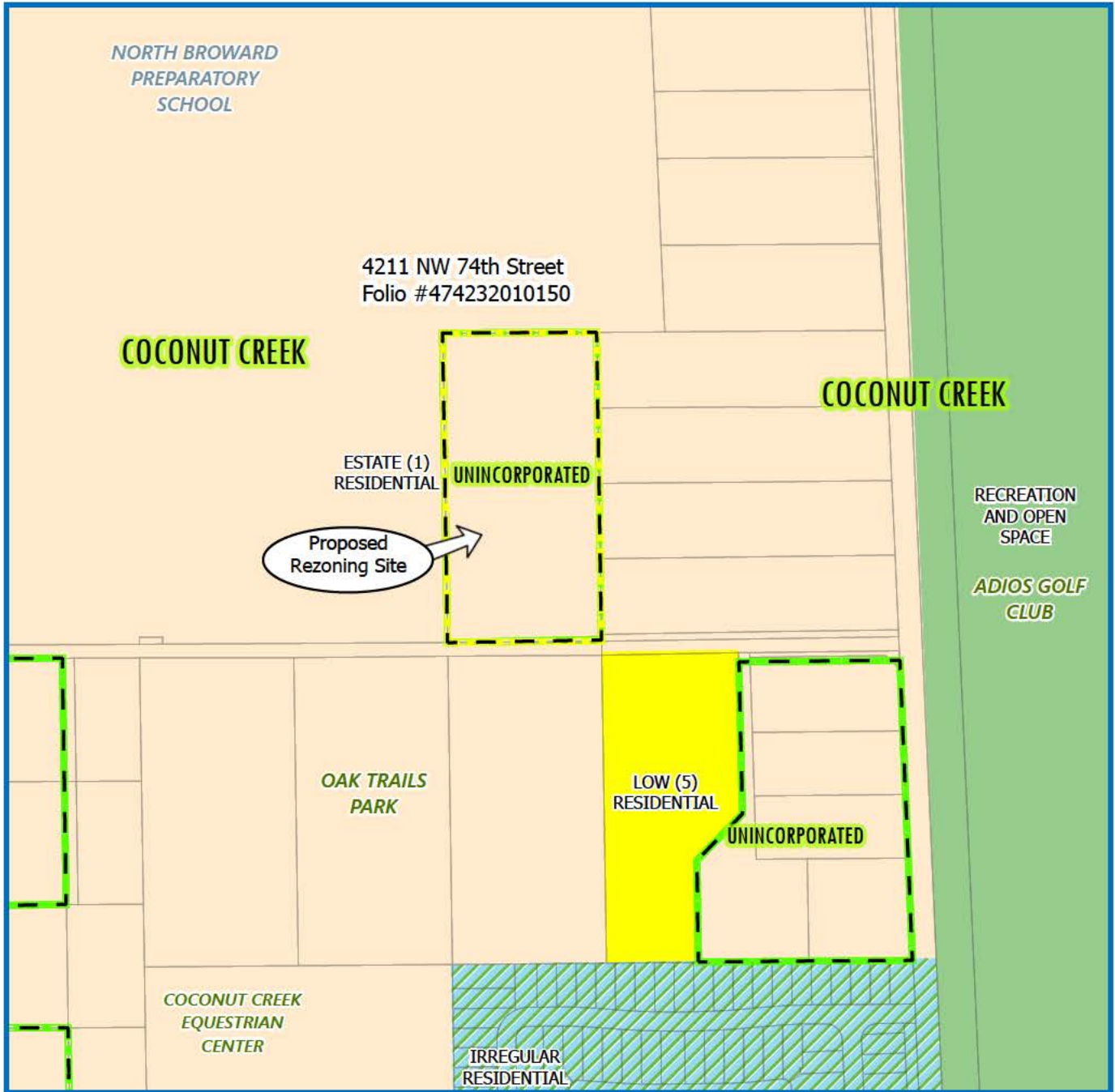

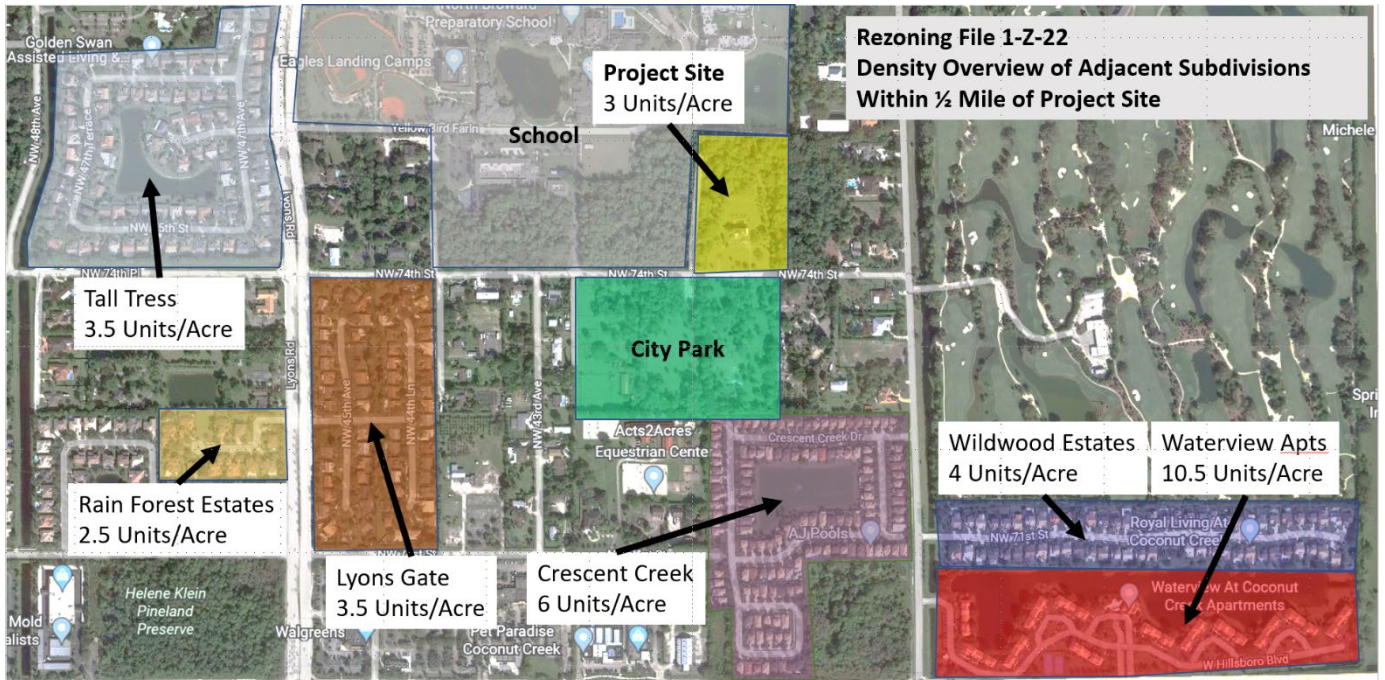
