WHEREAS, 49 CFR Part 21 effectuates the U.S. Department of Transportation's ("USDOT's") regulations for implementation of Title VI of the Civil Rights Act of 1964 ("Title VI") which prohibits discrimination on the basis of race, color, and national origin in programs and activities receiving federal financial assistance;

WHEREAS, the USDOT, Federal Transit Administration ("FTA") Circular 4702.1B provides guidelines for compliance with FTA Title VI requirements to transit agencies that receive financial assistance from the FTA:

WHEREAS, 23 CFR Part 200 effectuates the USDOT, Federal Highway Administration's ("FHWA's") Title VI regulations and provides guidelines for compliance with FHWA Title VI requirements to State highway agencies that receive financial assistance from the FHWA;

WHEREAS, the Florida Department of Transportation ("FDOT") is a direct recipient of FHWA funds and provides FHWA funds to eligible local agencies that adopt Title VI nondiscrimination plans which comply with FHWA Title VI requirements and Florida nondiscrimination laws;

1 WHEREAS, Broward County is a designated recipient of FTA funds and a 2 sub-recipient of FHWA funds from FDOT; 3 WHEREAS, every three (3) years, Broward County is required to submit a nondiscrimination plan in compliance with 49 CFR Part 21, Title VI of the Civil Rights Act 4 5 of 1964, FTA Circular 4702.1B, 23 CFR Part 200, and Florida nondiscrimination laws; 6 WHEREAS, the Broward County Transportation and Public Works Departments 7 have developed the Broward County 2020-2023 Title VI Program Plan, which complies 8 with FTA, FHWA, and FDOT requirements, for submission to the FTA and FDOT; and 9 WHEREAS, prior to submission, the Broward County 2020-2023 Title VI Program 10 Plan must be reviewed, approved, and adopted by Broward County's governing body, NOW, THEREFORE, 11 12 13 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF 14 BROWARD COUNTY, FLORIDA: 15 16 Section 1. The Broward County Board of County Commissioners hereby 17 approves and adopts the Broward County 2020-2023 Title VI Program Plan. 18 Section 2. The County Administrator is authorized to furnish all information and 19 documentation that the Federal Transit Administration may require in connection with the Broward County 2020-2023 Title VI Program Plan. 20 21 Section 3. The County Administrator is authorized to execute and submit the 22 Title VI Nondiscrimination Assurance form along with all information and documentation 23 that the Florida Department of Transportation may require in connection with the Broward 24
