Section 1. The recitals set forth in the preamble to this Resolution are true, accurate, and incorporated by reference herein.

Section 2. The Broward County Board of County Commissioners hereby assesses liens in the amount of the commodity charges owed to the County as listed in Attachment 1 against the affected parcels and properties.

Section 3. Each lien assessed against the affected parcels and properties shall be recorded as a Notice of Lien in the Official Records of Broward County, Florida, and shall constitute a lien upon said property. Each such lien shall be superior and paramount to the interest in such parcel or property of any owner, lessee, tenant, mortgagee, or other person or entity, excepting any lien of County taxes, and the lien assessed pursuant to this Resolution shall be on parity with the lien of such County taxes in accordance with Section 153.67, Florida Statutes, and Section 34-9 of the Code. The Notice of Lien shall be prima facie evidence of the debt to the County, and the debt shall bear interest at the legal rate.

Section 4. Severability.

If any portion of this Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Resolution. If any court determines that this Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Resolution to any other individual, group, entity, property, or circumstance.
