2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 ACCEPTING A DONATION IN THE AMOUNT OF
5 TWENTY THOUSAND DOLLARS (\$20,000) FROM THE
6 PETCO FOUNDATION, TO BE DEPOSITED IN THE
7 ANIMAL CARE ADOPTION TRUST FUND FOR THE
8 FUNDING OF LIFESAVING PROGRAMS; AUTHORIZING
9 THE COUNTY ADMINISTRATOR TO TAKE ALL
10 ADMINISTRATIVE AND BUDGETARY ACTIONS TO
11 IMPLEMENT ACCEPTANCE; AND PROVIDING FOR
12 SEVERABILITY AND AN EFFECTIVE DATE.

13 WHEREAS, The Petco Foundation, has donated to the Animal Care and Adoption
14 Division the amount of Twenty Thousand Dollars (\$20,000), to be used for the funding of
15 lifesaving programs;

16 WHEREAS, Section 18.63 of the Broward County Administrative Code provides
17 for the acceptance and acknowledgement by the Board of County Commissioners of
18 Broward County, Florida ("Board"), of donations to the County that are valued at
19 Ten Thousand Dollars (\$10,000) or more; and

20 WHEREAS, the Board wishes to accept the generous gift and express its gratitude
21 for the donation, NOW, THEREFORE,

22 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
23 BROWARD COUNTY, FLORIDA:

24 Section 1. The Board hereby accepts the donation from The Petco Foundation,
in the amount of Twenty Thousand Dollars (\$20,000), to be deposited in the Animal Care
Trust Fund and used for the funding of lifesaving programs of the Animal Care and
Adoption Division.

1 Section 2. The County Administrator is hereby authorized to take all
2 administrative and budgetary actions and execute all forms required to implement
3 acceptance of the donation.

4 Section 3. SEVERABILITY.

5 If any portion of this Resolution is determined by any Court to be invalid, the invalid
6 portion shall be stricken, and such striking shall not affect the validity of the remainder of
7 this Resolution. If any Court determines that this Resolution, or any portion hereof, cannot
8 be legally applied to any individual, group, entity, property, or circumstance, such
9 determination shall not affect the applicability hereof to any other individual, group, entity,
10 property, or circumstance.

11 Section 4. EFFECTIVE DATE.

12 This Resolution shall become effective upon adoption.
