The Office of Economic and Small Business Development (OESBD) has evaluated Hazen and Sawyer, PC's CBE participation for Engineering Services for Fine Bubble Aeration Basin Conversion as of August 31, 2020. This contract was awarded to Hazen and Sawyer, PC on February 10, 2015. The intent of the proposed first amendment is to extend the contract term to work in concert with the prime contractor as they complete the construction phase of this project.
