RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, APPROVING AMENDMENT NUMBER ONE TO THE PUBLIC TRANSPORTATION GRANT AGREEMENT WITH THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION FOR **FINANCIAL** PROJECT NO. 440097-2-94-01; INCREASING THE TOTAL COST OF THE GRANT PHASE FOR PROJECT NO. 440097-2-94-01 PARTY'S SHARE OF SUCH AND EACH COSTS VICE-MAYOR AUTHORIZING THE MAYOR OR ТΟ EXECUTE SAME: AUTHORIZING THE COUNTY ADMINISTRATOR ТΟ TAKE THE NECESSARY AND BUDGETARY ACTIONS; AND ADMINISTRATIVE PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

11 WHEREAS, on March 9, 2020, the State of Florida Department of Transportation 12 ("FDOT") and Broward County ("County") entered into a Public Transportation Grant 13 Agreement for Financial Project No. 440097-2-94-01 ("PTGA") to fund the Gate 14 Expansion and Terminal Connectors Phase II project at Fort Lauderdale-Hollywood 15 International Airport ("Project"), with an estimated grant phase of Ten Million Three 16 Hundred Ninety-five Thousand Five Hundred Eighty Dollars (\$10,395,580) ("Grant 17 Phase"), with FDOT contributing fifty percent (50%) of the Grant Phase up to a maximum 18 amount of Five Million One Hundred Ninety-seven Thousand Seven Hundred Ninety 19 Dollars (\$5,197,790), and the County contributing the remaining fifty percent (50%) of the Grant Phase, then determined to be Five Million One Hundred Ninety-seven Thousand 20 21 Seven Hundred Ninety Dollars (\$5,197,790), and any Project cost overruns; and

WHEREAS, FDOT and the County desire to amend the PTGA pursuant to
Amendment Number One to the PTGA ("Amendment 1") to increase the Grant Phase to
Twenty-eight Million Five Hundred Twenty-nine Thousand Five Hundred Thirty-eight

Dollars (\$28,529,538) and increase each party's share of the Grant Phase as follows:
FDOT's share of the Grant Phase will increase to a maximum amount of Fourteen Million
Two Hundred Sixty-four Thousand Seven Hundred Sixty-nine Dollars (\$14,264,769), or
fifty percent (50%) of the Grant Phase, whichever is lower; and the County's share of the
Grant Phase will increase to Fourteen Million Two Hundred Sixty-four Thousand Seven
Hundred Sixty-nine Dollars (\$14,264,769), or fifty percent (50%) of the Grant Phase, while
continuing to cover any Project cost overruns, NOW, THEREFORE,

8 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF9 BROWARD COUNTY, FLORIDA:

10 Section 1. The Broward County Board of County Commissioners hereby approves Amendment 1 (attached hereto as Exhibit 1), and authorizes the Mayor or 11 12 Vice-Mayor to execute Amendment 1, which increases FDOT's share of the Grant Phase 13 to a maximum amount of Fourteen Million Two Hundred Sixty-four Thousand Seven 14 Hundred Sixty-nine Dollars (\$14,264,769), or fifty percent (50%) of the Grant Phase, 15 whichever is lower, and increases the County's share of the Grant Phase to Fourteen 16 Million Two Hundred Sixty-four Thousand Seven Hundred Sixty-nine Dollars 17 (\$14,264,769), or fifty percent (50%) of the Grant Phase, with the County continuing to 18 cover any Project cost overruns.

Section 2. The County Administrator is hereby authorized to take the necessaryadministrative and budgetary actions to implement Amendment 1 of the PTGA.

21 Section 3. <u>Severability</u>.

If any portion of this Resolution is determined by any court to be invalid, the invalid
portion will be stricken, and such striking will not affect the validity of the remainder of this
Resolution. If any court determines that this Resolution, in whole or in part, cannot be

3	group, entity, property, or circumstance.
