Compliance Evaluation – First Amendment

The Office of Economic & Small Business Development (OESBD) has evaluated Kimley-Horn and Associates, Inc.'s (Kimley-Horn's) (prime's) utilization of CBE subcontracted firms. The CBE participation to date is 11.41%. An overview of the evaluation follows:

The Prime committed to 13.00% CBE participation.

Proposed First Amendment - The Prime's CBE commitment remains 13.00%

The purpose of the proposed First Amendment is to extend the agreement term, via two one-year renewal options, through June 22, 2022.

CBE Compliance Comments:

Kimley-Horn's current CBE participation is 11.41%, which is 1.59% less than its committed CBE participation. Participation was verified through an independent payment verification process.

Kimley-Horn informed the OESBD that it has outstanding invoices, in the amount of \$430,079.23, which are pending payment by the Broward County Aviation Department. Of this amount, \$88,236.23 is payable to Kimley-Horn's CBE subcontractors. Once these payments are made, the level of CBE attainment will be 13.50% ((\$88,236.23 + \$164,888.56)/(\$ 430,079.23 + \$1,444,491.41)). OESBD verified with the Broward County Aviation Department (BCAD) that these invoices are in fact pending payment in the amounts stated by the prime. Based on these pending payments, Kimley-Horn is poised to meet its CBE participation commitment.

The OESBD will continue to monitor this project for compliance with the CBE Program.
