The Office of Economic and Small Business Development (OESBD) has evaluated Mills Electric Service, Inc.'s CBE participation for the Electrical Maintenance and Repair as of April 15, 2021. This evaluation is for the consideration of a one-time threshold increase of \$385,000 dollars requested by the Broward County Water and Wastewater Operations Division (WWOD). This contract was awarded to Mills Electrical Services Inc. on October 13, 2017 for an initial two -year contract term with two (2) one- year options to renew for a potential four-year period. This review is based on information provided by the requesting agency and the prime contractor, Mills Electrical Service, Inc.

The CBE Goal for the overall agreement is 19% and Mills Electric Services, Inc.'s commitment is 19%. An overview is provided as follows:
