18	WHEREAS, Section 177.142, Florida Statutes, authorizes local governing bodies	
19	to amend plat names by ordinance upon a determination that a subdivision name	
20	appearing on a recorded plat or map constitutes an ethnic or racial slur;	
21	WHEREAS, the Sumter's Colored Addition to Town of Pompano Plat is recorded	
22	at Plat Book 1, Page 11, of the public records of Broward County, Florida; the Amended	
23	Plat of Sumter's Colored Addition to Town of Pompano Plat is recorded at Plat Book 1,	
24	Page 12, of the public records of Broward County, Florida; and the Sumter's Colored	

Addition to Pompano First Addition Plat is recorded at Plat Book 10, Page 67, of the public
 records of Broward County, Florida (collectively referred to as the "Plats"); and

WHEREAS, the Board of County Commissioners of Broward County determines
these names to constitute a racial slur and to be demeaning to racial and ethnic groups
and wishes to change the names of the Plats,

7 BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF
8 BROWARD COUNTY, FLORIDA:

Section 1. The name "Sumter's Colored Addition to Town of Pompano" is
hereby changed to "Sumter's Addition to Town of Pompano"; the name "Amended Plat
of Sumter's Colored Addition to Town of Pompano" is hereby changed to "Amended Plat
of Sumter's Addition to Town of Pompano"; and the name "Sumter's Colored Addition to
Town of Pompano First Addition Plat" is hereby changed to "Sumter's Addition to Town
of Pompano First Addition Plat."

Section 2. This Ordinance shall be recorded in the public records of BrowardCounty.

20 Section 3. In accordance with Section 177.142, Florida Statutes, Broward 21 County shall place a notation in the margin of the Plats indicating that an ordinance has 22 been passed changing the Plat names, the date of the name change, and the book and 23 page in the public records where this Ordinance is recorded.

1 Section 4. Severability. 2 If any portion of this Ordinance is determined by any court to be invalid, the invalid 3 portion will be stricken, and such striking will not affect the validity of the remainder of this Ordinance. If any court determines that this Ordinance, in whole or in part, cannot be 4 legally applied to any individual, group, entity, property, or circumstance, such 5 6 determination will not affect the applicability of this Ordinance to any other individual, 7 group, entity, property, or circumstance. 8 9 Section 5.
