The purpose of this letter is to inform you of the agreed upon sub-allocation of the Federal Fiscal Year (FFY) 2020 Section 5307 Urbanized Area Formula funds for the Miami Florida Urbanized Area. The Federal Transit Administration (FTA) posted Apportionment Tables for Fiscal Year 2020 on the FTA website on February 3, 2020, allocating the Miami UZA Section 5307 funds in the amount of \$108,946,625 and Section 5340 Growing State funds in the amount of \$6,033,753.

The sub-allocations were based on formulas and values as established by Table 5. The following table delineates the total allocation amount for each transit agency:
