1 ORDINANCE NO. 2 ORDINANCE OF THE BOARD OF COUNTY AN COMMISSIONERS OF BROWARD COUNTY, FLORIDA. 3 PERTAINING TO THE BROWARD COUNTY LIVING WAGE AMENDING SECTION 26-101 ORDINANCE; OF THE 4 BROWARD COUNTY CODE OF ORDINANCES ("CODE" AMENDING REQUIREMENTS FOR SKYCAPS AND 5 **EMPLOYEES** PERFORMING PORTER ASSISTANCE LIVING SERVICES TO RECEIVE WAGE; AND 6 PROVIDING FOR SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE. 7 8 (Sponsored by Commissioner Mark D. Bogen) 9 10 WHEREAS, the Broward County Board of County Commissioners ("Board") finds that the Fort Lauderdale-Hollywood International Airport ("Airport") generates significant 11 12 revenue for Broward County, and that the smooth and continuous operation of services 13 at the Airport is crucial to the viability and growth of the Airport; 14 WHEREAS, Broward County has a proprietary interest in ensuring that Airport 15 services are not disrupted because such disruption would disserve the public and would 16 result in a substantial loss of Airport revenue; 17 WHEREAS, the Broward County Living Wage Ordinance ("Living Wage 18 Ordinance") promotes the general welfare, health, and prosperity of Broward County by 19 enabling workers to better support and care for their families and to fully participate in 20 Broward County's economic, civic, and cultural experiences; 21 WHEREAS, numerous studies suggest that living wage laws benefit employers 22 and the economy as a whole by improving employee performance, reducing employee 23 turnover, and lowering absenteeism, thereby improving productivity and the quality of the 24 services provided by the employees;

5	skycaps an	d employees performing porter assistance services and to safeguard the
6	significant re	evenue generated at the Airport,

12	amended to	read as follows:

15	<u>all</u> other <u>s;</u> us	se of the plural shall include the singular; and use of the singular shall include
16	the plural. 1	he following definitions apply unless the context in which the word or phrase
17	is used requ	ires a different meaning:

19	(h)	Covered employee means:
20	(1)	Each individual employed by a service contractor for a minimum of twenty
21		(20) hours per week who, during the employment, is or was involved in
22		providing services pursuant to the service contractor's contract with the
23		County, except where the individual's primary compensation is composed
24		of gratuities <u>tips;</u>

1	(2)	Each individual employed by an airline service provider who, during the
2		employment, is or was involved in providing covered airport services
3		pursuant to Section 26-101(I). Individuals employed by an airline service
4		provider whose primary compensation is composed of gratuities <u>tips</u> are not
5	(covered employees, except for wheelchair attendants <u>, skycaps, and</u>
6	9	employees performing porter assistance services, including curbside
7	9	check-in, as described in Section 26-101(I)(6); and
8		
9	(I)	Covered airport services means the following services:
10		
11	(6)	Porter Service for Air Carrier. To handle and transport passenger baggage
12		and other articles of personal property through the terminal buildings and
13		areas, including the United States Federal Inspections areas and
14	-	Transportation Security Administration areas. Such service includes, but is
15		not limited to, skycaps, wheelchair attendants, luggage runners, and electric
16	(cart drivers <u>, and employees performing porter assistance services,</u>
17	i	including curbside check-in. An airline service provider is not required to
18	1	pay a living wage to a skycap who handles luggage, performs curb side
19		check-in, and works primarily for gratuities;
20		
21	Section	n 2. <u>Severability</u> .
22	lf any p	portion of this Ordinance is determined by any court to be invalid, the invalid
23	portion will be	stricken, and such striking will not affect the validity of the remainder of this
24	Ordinance. If	any court determines that this Ordinance, in whole or in part, cannot be

1	legally applied to any individual, group, entity, property, or circumstance, such
2	determination will not affect the applicability of this Ordinance to any other individual,
3	group, entity, property, or circumstance.
4	Section 3. Inclusion in the Broward County Code of Ordinances.
5	It is the intention of the Board of County Commissioners that the provisions of this
6	Ordinance become part of the Broward County Code of Ordinances as of the effective
7	date. The sections of this Ordinance may be renumbered or relettered and the word
8	"ordinance" may be changed to "section," "article," or such other appropriate word or
9	phrase to the extent necessary in order to accomplish such intention.
10	Section 4. <u>Effective Date</u> .
11	This Ordinance is effective as of the date provided by law.
