2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 AUTHORIZING APPROPRIATION AND DISBURSEMENT
5 OF FLORIDA DEPARTMENT OF CHILDREN AND
6 FAMILIES FISCAL YEAR 2021-2022 GRANT FUNDS IN THE
7 AMOUNT OF \$420,162 TO PROVIDE EMERGENCY
8 SHELTER SERVICES, RAPID REHOUSING SERVICES,
9 RENT PAYMENT ASSISTANCE, AND SUPPORTIVE
10 SERVICES TO INDIVIDUALS AND FAMILIES
11 EXPERIENCING HOMELESSNESS, AND FOR
12 ADMINISTRATIVE SERVICES; AUTHORIZING THE
13 COUNTY ADMINISTRATOR TO EXECUTE AMENDMENTS
14 TO EXISTING AGREEMENTS WITH SPECIFIED SERVICE
15 PROVIDERS AND TAKE ALL NECESSARY
16 ADMINISTRATIVE AND BUDGETARY ACTIONS TO
17 IMPLEMENT THE AGREEMENTS; AND PROVIDING FOR
18 SEVERABILITY AND AN EFFECTIVE DATE.

12 WHEREAS, the Florida Department of Children and Families (“DCF”) has awarded
13 Broward County three-year funding for four (4) projects to assist individuals and families
14 experiencing homelessness in Broward County, and for administrative services to
15 increase the capacity of the local homeless assistance continuum of care;

16 WHEREAS, on June 11, 2019, and October 20, 2020, the Board of County
17 Commissioners of Broward County, Florida (“Board”), provided the first and second year
18 of DCF funding to specified service providers for emergency shelter services, rapid
19 rehousing services, rent payment assistance, and supportive services to individuals and
20 families experiencing homelessness, and for administrative services (collectively, the
21 “Services”);

22 WHEREAS, the Board desires to provide the third year of DCF funding to specified
23 service providers for the provision of the Services for fiscal year 2021-2022;

1 WHEREAS, the Board desires to authorize the Broward County Administrator
2 (“County Administrator”) to execute, on behalf of the County, amendments to existing
3 agreements with the specified service providers; and

4 WHEREAS, the Board finds that the Services to be funded benefit the residents of
5 Broward County and serve a public purpose, NOW, THEREFORE,

7 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
8 BROWARD COUNTY, FLORIDA:

10 Section 1. Authorized Appropriation and Disbursement.

11 The Board hereby authorizes appropriation and disbursement of funds in the
12 aggregate amount of Four Hundred Twenty Thousand One Hundred Sixty-two Dollars
13 (\$420,162) as set forth in Attachment A for fiscal year 2021-2022, commencing on July 1,
14 2021, and ending on June 30, 2022.

15 Section 2. Execution by the County Administrator.

16 The County Administrator is hereby authorized to execute amendments providing
17 third-year funding to the existing agreements with the service providers identified in
18 Attachment A. The County Administrator is also authorized to take all necessary
19 administrative and budgetary actions to implement the agreements. Nothing in this
20 Resolution alters the requirement that agreements be reviewed for legal sufficiency by
21 the Office of the County Attorney before execution. Any material deviations from the
22 applicable Board-approved form agreement must be presented to the Board for approval.

1 Section 3. Severability.

2 If any portion of this Resolution is determined by any court to be invalid, the invalid
3 portion will be stricken, and such striking will not affect the validity of the remainder of this
4 Resolution. If any court determines that this Resolution, in whole or in part, cannot be
5 legally applied to any individual, group, entity, property, or circumstance, such
6 determination will not affect the applicability of this Resolution to any other individual,
7 group, entity, property, or circumstance.

8 Section 4. Effective Date.

9 This Resolution is effective upon adoption.
