ADDITIONAL INFORMATION The Office of Economic and Small Business Development (OESBD) designated this a reserved project for County Business Enterprise (CBE) firms. The OESBD has determined that YJ & R Landscaping Services, Inc. meets the eligibility criteria of the CBE reserve program.						
The purpose of this contract is to furnish labor, materials, equipment, services, and incidentals for the Pressure Cleaning Service at bus terminals, garages and other Broward County facilities.						
Solicitation No. BLD2124731B1 was solicitated to the open market on July 25, 2022 and opened on August 10, 2022. Ten (10) submittals were received with no declinations from the following vendors:

On January 5, 2023, in accordance with the December 13, 2022 - Agenda Item No. 25, approved by the Board of County Commissioners, the County Administrator approved open-end contract to responsive, responsible bidder, King of Pressure, Inc., for Pressure Cleaning Services, Solicitation No. BLD212473181, for the Facilities Management Division, in the initial three-year estimated amount of \$914,757, which includes \$41,250 for allowances, for a five-year potential estimated amount of \$1,524,595. The contract began on February 22, 2023 and will end on February 23, 2026.

On May 9, 2023, King of Pressure, Inc. via email submitted a letter of resignation from the Contract. King of Pressure claimed, "We are not able to meet the requirements set fourth in the bid package to achieve the required goal of 25% CBE participation. This expectation will cause my company to be non-compliant...For us to cover that now after the fact would impact us financially".

On July 6, 2023, Notice of Termination was transmitted via Certified Mail (7005 3110 0002 8833 9039) and emailed to King of Pressure, Inc., pursuant to the Contract's General Conditions, Section 4(c) ("Termination For Convenience"), "the County may terminate the contract for convenience upon no less than thirty (30) days written notice.

The Purchasing Division and Facilities Management Division recommends the approval to terminate the contract and have the Director of Purchasing proceed to award a contract to the next lowest responsive, responsible bidder from this solicitation.

All prices, terms and conditions will remain fixed for the first twelve (12) months of the contract period. Upon completion of the first twelve (12) months contract period, the contractor may make a timely request for an annual price adjustment, prior to the renewal date, for years two through five, in accordance with the price adjustment clause term of the contract. The initial contract period shall begin the date of award and terminate three years from that date.

The allowance items included in this contract, in the total annual amount of \$13,750, includes parts, materials and lift/rental equipment. Expenditures under these allowance items must be approved by the Contract Administrator and will be reimbursed at the contractor's actual incurred cost, without mark-up.

In accordance with the Broward County Living Wage Ordinance, Broward County Administrative Code, Section 26-101(i), these services are covered services. YJ & R Landscaping Services, Inc. has agreed to be bound to the contractual obligations of the Living Wage Ordinance.

Facilities Management Division reviewed the bid submitted by YJ & R Landscaping Services, Inc. and concurs with the recommendation for award. One vendor performance evaluation was completed for YJ & R Landscaping Services, Inc.; the firm has an overall performance rating of 4.92 out of possible rating of 5.0. Copies of the vendor performance evaluation is available upon request.

Incumbent Vendor: YJ & R Landscaping Services, Inc., Contract Number and Title: Contract No. BLD2118805B1, Pressure Chemical Cleaning Services. Contract Term: November 26, 2019 through February 23, 2023. Expenditures to date: \$ 3,203,709.54.

The Purchasing Division reviewed the prices submitted by the recommended vendor, YJ & R Landscaping Services, Inc., and determined that the prices submitted are fair and reasonable in comparison to prices of the other bidders in this solicitation.

The bid posted on July 25, 2022 and opened on August 10, 2022; Ten bids were received with zero declination.

The Recommendation for Award was posted on the Purchasing Division website from July 19, 2023 through July 26, 2023. There was no protest or appeal filed against this procurement.

In accordance with the June 13, 2023, Agenda Item No. 29, approved by the Board of County Commissioners, the County Administrator is authorized to approve and/or execute agreements, contract amendments, work authorizations, advertisements of competitive solicitations and other documents during the 2023 Board Summer Recess, June 14, 2023 through August 22, 2023.
