RESOLUTION NO.

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, ASSESSING LIENS PURSUANT TO SECTION 153.67, FLORIDA STATUTES, AND SECTION 34-9 OF THE BROWARD COUNTY CODE OF ORDINANCES, AGAINST THE AFFECTED PARCELS AND PROPERTIES FOR UNPAID WATER AND WASTEWATER ACCOUNTS; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, Broward County, Florida ("County"), provides water and wastewater services to many of the county's residents, and some of those residents have unpaid balances;

WHEREAS, the County mailed notices of default to account holders with unpaid balances in accordance with Section 34-9 of the Broward County Code of Ordinances ("Code");

WHEREAS, the unpaid water and/or wastewater accounts listed in Attachment 1 have remained unpaid for more than thirty (30) days after the mailing of the notices of default; and

WHEREAS, Florida statutory law and the Code permit the assessment of a lien against the affected property if the water and/or wastewater services balances remain unpaid for more than thirty (30) days after notice of default, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

23           Section 1.    The recitals set forth in the preamble to this Resolution are true,  
24 accurate, and incorporated by reference herein.

25           Section 2.    The Broward County Board of County Commissioners hereby  
26 assesses liens in the amount of the commodity charges owed to the County as listed in  
27 Attachment 1 against the affected parcels and properties.

28           Section 3.    Each lien assessed against the affected parcels and properties shall  
29 be recorded as a Notice of Lien in the Official Records of Broward County, Florida, and  
30 shall constitute a lien upon said property. Each such lien shall be superior and paramount  
31 to the interest in such parcel or property of any owner, lessee, tenant, mortgagee, or other  
32 person or entity, excepting any lien of County taxes, and the lien assessed pursuant to  
33 this Resolution shall be on parity with the lien of such County taxes in accordance with  
34 Section 153.67, Florida Statutes, and Section 34-9 of the Code. The Notice of Lien shall  
35 be prima facie evidence of the debt to the County, and the debt shall bear interest at the  
36 legal rate.

37           Section 4.    Severability.

38           If any portion of this Resolution is determined by any court to be invalid, the invalid  
39 portion will be stricken, and such striking will not affect the validity of the remainder of this  
40 Resolution. If any court determines that this Resolution, in whole or in part, cannot be  
41 legally applied to any individual, group, entity, property, or circumstance, such  
42 determination will not affect the applicability of this Resolution to any other individual,  
43 group, entity, property, or circumstance.

44 Section 5. Effective Date.

45 This Resolution is effective upon adoption.
