1. Access

Highway Construction and Engineering Division, Traffic Engineering Division and Transit Division have reviewed the proposed NVAL Amendment and recommend **approval** subject to the conditions contained in the attached memorandum **(Exhibit 4)**. This request shall meet the standards of the Broward County Land Development Code at the time of permit.

Section 5-184(d)(2) of the Broward County Land Development Code requires a recordable agreement for the required improvements. The owner of this plat shall enter into the standard Installation of Required Improvements Agreement (BCF#450) and submit it to the Highway Construction and Engineering Division for review and approval prior to plat recordation. The use of a non-standard agreement will require independent approval by the County Commission.

This project is located on West Atlantic Boulevard, which is a State Road. Florida Department of Transportation (FDOT) has issued an Approval Letter with conditions. Openings or improvements on functionally classified State Roads are subject to the "Rules of the Department of Transportation Chapter 14-97 State Highway System Access Management Classification System and Standards." This determination will expire on September 30, 2025, and an updated FDOT letter is required prior to NVAL approval.

2. Municipal Review

The City of Pompano Beach has submitted a Letter of No Objection dated December 19, 2024, supporting the NVAL amendment.

RECOMMENDATIONS

In addition, staff recommends that the Board authorize the Mayor to sign an order approving this agenda item subject to staff findings and conditions.
