Concurrence – Additional Information

Based on the findings below, Broward County Aviation Department - Maintenance Division (BCAD) does not concur with award of Bid No. BLD2126849B1- Pre-Conditioned Air Units (PCA) and Replacement Parts (Group 2) to Twist Aero, LLC (Twist).

BCAD staff contacted the three (3) references provided in Twist's bid response. Only the Denver Department of Aviation responded. The reference provided included multiple poor ratings. Multiple requests were made to Twist via phone and email for assistance with getting references to respond and subsequently to provide additional references. Twist was not helpful and not interested enough to ask their references to respond. BCAD staff spoke with the reference from Denver Department of Aviation at length to understand the basis behind the poor rating. BCAD determined that while Twist's product meets the requirements of the bid, Twist struggles to provide professional customer service, accurate billing, and meet delivery schedules. FLL requires a vendor that can provide equipment that meets operational requirements as well as provides professional, dependable and timely services. In the past, BCAD has done business with vendors that have provided subpar services and equipment that have impacted FLL operational needs.

Based on the findings below, Broward County Aviation Department - Maintenance Division (BCAD) does not concur with award of Bid No. BLD2126849B1– Pre-Conditioned Air Units (PCA) and Replacement Parts (Group 2) to JBT AeroTech Corporation (JBT).

BCAD evaluated JBT's response to the above referenced Bid and has determined the product offered in Bid Line BLD2126849B1-03-01 – Group 2: 60 Ton PCA with Trailer does not meet the Bid Specifications and Requirements.

Per the Bid's Specifications and Requirements, Section 5.14.A., "PCA unit must mount on trailer for mobile use, including diesel engine or approved equal, generator set, and hosing equipment."

JBT has confirmed that the model offered in their response, model #SJ-115, is for a 60-ton PCA unit with trailer that does not include a self-powered diesel system and requires a separate power source for the unit. The price offered does not include the cost of providing the separate power source. JBT offers alternatives, but they do not meet the tonnage requirements of the PCA unit, per the Specifications and Requirements, Section 4.3.B.
