**Re: Supplemental Budget Appropriation Request –
Inmate Catastrophic Medical Care**

Dear Mr. Ruiz:

The Broward Sheriff's Office requests the Broward County Administrator's assistance with completing a Supplemental Budget Appropriation involving Inmate Catastrophic Medical Care.

Pursuant to Florida Statute 901.35, the general fund of the county in which a person was arrested for a violation of state law is the funding source of last resort for injury or illness sustained by the person during the arrest. If an inmate does not have regular medical insurance and is not eligible for Medicaid coverage, and is determined to be indigent, this statutory provision applies.

BSO's agreement with our inmate health services provider excludes charges for treatment received after any hospital admission, to include hospital admissions that are a result of injury or illness sustained by the person during the arrest. BSO works with our inmate health services provider and local hospitals where inpatient treatment is provided to receive, process and validate these medical bills and ensure that only equitable costs are incurred for this Inmate Catastrophic Medical Care service. Upon receipt of funding from Broward County, BSO then pays these medical bills on behalf of Broward County.

We request that the Broward County Board of County Commissioners authorize a transfer from the County's general fund to BSO's regular operating budget in order to satisfy obligations to local hospitals for Inmate Catastrophic Medical Care.
