The Broward County Regional Emergency Services and Communications Division is seeking to purchase data center server computing hardware and hypervisor virtualization software with accompanying support services. We are requesting that we purchase from the same certified hardware vendor that is used for our Motorola CAD to ensure seamless integration and compatibility. Also, we are requesting for Hewlett Packard equipment to be standardize. This equipment will be purchased as a replacement for existing server hardware and software that has reached end of life. The new computer hardware and hypervisor virtualization software will be used to support proprietary public safety applications, upgrades, databases, logging, backups, and disaster recovery efforts.

For purposes of seamless integration, compatibility, and streamlined support, we would like to stay uniform with our computing infrastructure. Our Motorola CAD infrastructure is currently operating on a certified HPE platform and by using HPE data center equipment, we can ensure compatibility between the different computing devices and software. The components in the purchase request will be connecting to existing HPE computing hardware and software which will enable seamless integration. The manufacturer (HP) guarantees and provides a compatibility matrix to ensure that specific server hardware components can work as intended when connecting to other HPE infrastructure devices. There is a benefit to having a single manufacturer provider for all routine maintenance tools and a single support phone number for Broward

We have reviewed servers from Dell and Hewlett Packard. These manufacturers use a common type of computer hardware but offer management software that is unique and proprietary to their hardware. We will benefit by having a single hardware manufacturer for both our compute and storage equipment for centralized management, compatibility, interchangeability, and interoperability purposes.

A Request for Information (RFI) No. TEC2127020F2 was issued on January 09, 2024, to determine if other vendors are able to provide the requested services. The RFI closed on January 17, 2024, with zero responses submitted. There were 25 views, and no vendor questions were asked. 12,261 vendors were successfully invited.

The County's 911 call centers currently utilizes Motorola PremierOne Computer Aided Dispatch (CAD) system software that is utilized by dispatchers, call-takers and 911 operators to prioritize and record incident calls, identifies the status and location of first responders in the field and effectively dispatches first responders personnel. Motorola configures their PremierOne CAD Systems with HPE products. HPE servers, storage solutions, maintenance, services and support, including professional installation services, through HPE Authorized Partners was identified as the Sole Brand product to meet Broward County requirement.

Per the Procurement Code, Section 21.25, Sole Source Procurement and 21.26, Sole Brand Procurement, Section (b), the purchasing Agent affirms that this request is the subject of an RFI, and the required due diligence has been completed and therefore recommends approval of this Sole Brand standardization request.
